Coordinated Assessment Report

Jeff Rawlings reported that the committee met following the December meeting but no one was approved for RRH or PSH. The committee discussed the normal delay in getting the contracts from ESG in 2019. No clients were put forward at the December meeting. The need for representation from all nine counties was stressed and a plea issued for all the unrepresented counties.

PIT Count Training

Jeff Rawlings conducted a brief training regarding building the proper support for collecting data from the unsheltered populace. He also discussed the need to start immediately with raising awareness of the impending count. Some locations to consider for engaging the homeless populace are the library, soup kitchens, known homeless camps, 24hr Laundromats, and other 24hr store locations. He also stressed getting churches, civic groups and other nonprofits to assist with the count.

Grantee Updates

SAFE of Harnett County – Tonya Gray reported they currently are housing three families. Three families were exited in December. One family returned.

Friend to Friend – Nicole Bennett reported two current families including one newborn. Five persons being served total at present.

JLHCA – Jeff Rawlings reported that the funds for the 2018 RRH year had been totally depleted. Currently there are 30 clients in Johnston County, 30 in Lee County and 12 in Harnett County.
