Introductions

Approval of Meeting Minutes

• The committee reviewed the minutes from September's meeting. There were no changes to the minutes. Carolyn made a motion to approve the minutes and it was seconded by Betsy.

Updates – NC Balance of State Steering Committee

- ESG Application
 - o The applications are now under review and final decisions should be announced by November 25, 2019
 - O December 6th agency's intent to appeal is due
 - o December 13th appeals and special consideration materials due
 - o January 3rd appeal responses and contracts sent out
- Elections
 - o 2020 Regional Committee Elections should begin in 4th quarter meetings
 - o To promote coverage, a single agency should not full more than 2 leadership positions on the Regional Committee
 - o Positions to be filled: Regional Lead, Regional Alternate, Webmaster, Coordinated Entry Lead, PIT Lead, ESG Funding Process Lead, and CoC PRC Representative

Restructuring of the Committee

- The committee had a discussion on the direction of the committee. It was suggested that all members continue to reach out to other agencies to get them involved
- It was also suggested that the regional committee break up into smaller committees. Each subcommittee would have a lead, secretary and PIT contact

- o Group 2 Hertford and Gates
- o Group 3 Camden, Chowan, Perquimans, Pasquotank and Currituck
- If the group decides to have regional subcommittees, it will begin January 2020

ESG Funding Update

- The application was sent to the NCCEH staff for review. They have not responded with their feedback. They will notify everyone by November 25th
- River City CDC was the only agency to apply for ESG Funding. They applied for Street Outreach and Rapid Re-housing funding
- The ESG office asked that the Regional Committee explain some things concerning the Regional Application. Those items will be corrected and submitted by the deadline

PIT Count

- The purpose of the PIT count was discussed it is a nationwide count of people experiencing homelessness. The count will take place on January 29, 2020
- The count will be done by using an app no paper surveys
- The count will include sheltered and unsheltered individuals
- The Balance of State will host a series of webinars to help train for the count. When the dates are released, the committee will be notified
