

NCCEH and the NC Emergency Solutions Grants Office at the NC Department of Health and Human Services are hosting a virtual meeting for shelters, transitional houses, day centers or other congregate facilities serving people experiencing homelessness to discuss the response to COVID-19. We know shelters are working on the top priority of maintaining the safety of their clients and staff at this time.

NC Courts stop evictions and foreclosures as part of coronavirus response

"North Carolina will stop eviction and foreclosure hearings for the next 30 days as part of the court system's latest effort to reduce courthouse traffic and slow the spread of the coronavirus. While the announcement late Sunday offered some potential relief to the state's at-risk families, the Mecklenburg County Sheriff's Office said Monday that eviction orders already in the pipeline will be carried out unless the courts step in to stop them."
