Approval of Consent Agenda

- The consent agenda was voted on as a whole at the beginning of the meeting. Without changes or objection, the consent agenda was approved by common consent.

COVID-19 Response

The statewide response is being coordinated by the North Carolina Interagency Council for Coordinating Homeless Programs (ICCHP) with the goal of developing a statewide COVID-19 response and recovery plan related to those who are experiencing homelessness or housing insecurity. An actionable, comprehensive plan will be developed to ensure homelessness--due to or exacerbated by COVID-19--is prevented; or if it cannot be prevented, is rare, brief, and one-time only. The ICCHP will refine needed activity, create a plan to operationalize, and identify budget needs.

The work of the ICCHP is divided into two workgroups as follows:

- Crisis Response Workgroup
 - Supporting sheltered and unsheltered populations:
 - Coordinate state response and guidance for shelters to adjust to "new normal" and connecting these efforts with non-congregate shelters.
 - Identify and distribute best practices for coordination of testing/screening, safe shelter operations, and identify needed resources for shelters.
 - Non-congregate sheltering options
 - Supporting counties and providers to access FEMA reimbursement for establishing non-congregate shelter options in hotels.
 - Identify and distribute guidance and best practices to communities establishing and maintaining non-congregate sites.
- Housing Stability Workgroup

Goal: Obtain and Maintain Permanent Housing

- Replicate Back@Home to coordinate state rehousing and prevention activities and connect these efforts with non-congregate shelters.
 - Housing Navigation
 - Financial Assistance
 - Housing Stabilization
 - Adapt to different situation and funding sources
- Add additional activities
 - Low barrier, immediate financial assistance
 - Legal assistance
 - Link mainstream resources.

The idea is to address challenges with prevention, diversion, and rapid rehousing statewide. The NC BoS CoC response is to support shelters and service providers and coordinate with state efforts and support efforts to establish non-congregate shelter sites in the CoC.

2020 Point-In-Time/Housing Inventory Count Update

Due to the COVID-19 response, HUD delayed the final submission date for the 2020 PIT/HIC in HDX to June 30, 2020. NCCEH staff are continuing to work to collect and verify information.

 NCCEH staff will release PIT/HIC information to the Steering Committee and individual Regional Committees as soon as possible.

CoC Competition Updates

HUD announced the initial steps of the FY20 CoC competition:

- Registration reviewed and approved by HUD
- Grant Inventory Worksheet (GIW) delayed
- Notice of Funding Availability (NOFA) release delayed

 This is required of for any agency seeking to apply for new projects. The deadline will be two weeks after the NOFA is released. Intent to apply information is non-binding, meaning that projects can shift and change to meet the needs of agencies and regions.
 NCCEH staff will review and follow-up with each agency to discuss projects starting in May.

- The Scorecard Committee held the first of three working meetings to begin updating the 2019 renewal and new scorecards. The Steering Committee will consider approval of scorecards at its June 2020 meeting.

Racial Equity Subcommittee Update

The subcommittee will begin meeting on the third Wednesday of each month. Two liaisons have been selected and will report out to the Steering Committee during its monthly meetings. The subcommittee is currently working with the CoC Scorecard Committee to ensure that the funding process includes a racial equity component, including ways to reward agencies for incorporating racial equity into their everyday processes. The internal team is also recruiting subcommittee members to work on the annual, HUD-mandated Racial Equity Assessment.
