Approval of Consent Agenda

- The consent agenda was sent out for review prior to the meeting and is posted at: <u>https://www.ncceh.org/bos/steeringcommittee/</u>
- The consent agenda was voted on as a whole at the beginning of the meeting. Without changes or objection, the consent agenda was approved by common consent.

2021 ESG Annual Allocation Recommendation

Brian Alexander walked the Steering Committee through the process followed by the Project Review Committee to consider the 34 renewal certifications and 6 new applications submitted for review and consideration. Using NCCEH staff to review all the renewal certifications, none were flagged for further PRC review. Each of the new project applications were reviewed three times by 1 CoC staff person and 2 PRC members.

To arrive at the final applicants and funding amounts, the staff and PRC reviewed the Fair Share amount for each Regional Committee to determine if it exceeded the 60% cap for Emergency Response activities (SO and ES). Regions fell into three categories:

- Category 1: Equal to Fair Share and within ER maximums
- Category 2: Less than Fair Share and within ER maximums
- Category 3: More than Fair Share and outside ER maximums

The PRC used the following criteria as precedent to make consistent decisions for the proposed slate of grantees in each region:

- Allocate extra available funding to RRH financial assistance
 - If one RRH program, give all to RRH applicant.
 - If multiple RRH programs, look at Review Tool performance criteria to determine most effective applicant to allocate funding.
- Attempt to fund good, new Project Applications that can meet Written Standards by 01/01/21
- Prioritize funding to agencies that did not apply for ESG-CV funding
- Evaluate staff and financial capacity to spend requested funding
- Review funding requests in 2021 versus awarded funding amounts in 2020
- Reduce agencies with Tier 2 and Tier 3 spending per NC ESG Office criteria
 - Tier 2: reduce to 80% of request
 - Tier 3: reduce to 50% of request
- Consider Regional Committee priorities and recommendations

PRC Recommendations--

The PRC recommended all renewal agencies for continued funding in 2021 and most at their requested funding levels with the following exceptions:

- Additional funds for RRH projects in regions not at Fair Share level
- Small reductions to include new projects in regions and to meet Fair Share level
- Eliminated The Haven of Transylvania County's RRH project because of size and scope
- Reduced request for Outreach Mission to 2020 ESG award amount and Thrive to similar 2020 ESG award amount
- Reduced 4 agency requests due to spending issues:
 - Region 3: Dulatown Outreach Center Tier 2 reduced to 80% of request
 - Region 6: Christian Help Center Tier 2 reduced to 80% of request
 - Region 10: Salvation Army Tier 2 reduced to 80% of request
 - Region 10: Greene Lamp Tier 3 reduced to 50% of request

The PRC recommended 5 new projects for funding given their adherence to best practices and their ability to meet the CoC's written standards by 01/01/21:

- Homes of Hope: ES, HMIS in Region 5
- Family Abuse Services: HP in Region 6
- Hand Up Ministries: ES in Region 9
- Salvation Army of Goldsboro: ES in Region 10
- River City Community Development: ES in Region 11

Several clarifying questions were raised and answered in response to a closer look at the tables below. Marie Watson asked for more detailed clarification on how the Fair Share for Region 7 was calculated—to which Brian provided both verbal and written explanations.

2020 Virtual Steering Committee Retreat

Kevin McNamee reported that the Racial Equity Subcommittee and NCCEH have finalized a contract with *C4 Innovations: Race Equity Design and Implementation* (REDI) to provide racial equity training for the Steering Committee and the Racial Equity Subcommittee. In lieu of the annual, in-person meeting, we will hold a virtual racial equity training for 2020. This will comprise two 90-minute trainings on Nov. 10 and 17 from 12:30-2:00 p.m. The registration link and pre-training survey is forthcoming from C4 Innovations the week of October 12th. All Steering Committee and RE Subcommittee members are expected to attend.

Racial Equity Subcommittee Update

Stephanie Gilliam relayed that the Racial Equity Subcommittee received the Steering Committee's adoption of the 2020 Racial Equity Assessment and is currently reviewing and prioritizing actionable next steps. The Subcommittee also hosted the third Racial Equity Dialogue on September 29 with over 70 people in attendance. It featured a panel discussion on *Racism in the Justice and Re-Entry Systems*. The fourth, and final, Racial Equity Dialogue on *Racism and Voting* will be held on Tuesday, October 20 at 12:00 P.M.

Social Security Administration and ID Issues

Debra A. Susie outlined recent reports from case managers in the field that Social Security Administration (SSA) offices are not allowing in-person appointments to get a Social Security card but requiring people to mail documentation, including picture IDs, to the field office. This was confirmed by Lisa Wallace w/SSA in Charlotte.

SSA's coronavirus webpage states: *If you have a critical situation that we cannot help you with by phone, online, fax, or mail, we may be able to schedule an in-office appointment for you (https://www.ssa.gov/coronavirus/*). Case managers have called the SSA national phone number and local offices to request appointments for these critical and dire needs, but the offices will not schedule an appointment. Because picture IDs are key to accessing many services, housing programs, and employment opportunities, the mailing of IDs puts them at risk of getting lost or stolen. Case managers have said they would like to be able to either schedule in-person appointments at SSA for their clients or take documentation to the office for quick verification so that IDs do not have to be mailed.

After a meeting last week with NC Division of Motor Vehicles Commissioner Torre Jessup, NCCEH submitted a list of 563 agencies in NC working with people who are experiencing homelessness. This is the first step in working with DMV staff to develop a system that eliminates barriers for homeless individuals to obtain whatever they need to improve their access to housing, employment and voting. The NC DMV has collaborated with the SSA to establish a system-to-system verification that allows NC drivers license and identification card holders to order a replacement Social Security card online.

SC members were encouraged to share this information with and advise case managers to report why the online system may not work for some of the households they serve to Emily Carmody at emily@ncceh.org.
