 - Cabarrus- N/A
 - o Davidson
 - (Emergency Shelter)- allowing new people in shelter and allowing people to leave shelter, other shelters aren't taking people in and so often people are dropped off at their shelter and stranded, outdoor handwashing stations, in talks with architect (new building will house 124 people), new client working with CLink having challenges with communication
 - (Domestic Violence Shelter) stays in close communication with case managers at Clink to help having a coordinated effort with people that have been referred. In the last 2 weeks, calls have been high. Over the
 - o Rowan
 - (Emergency Shelter)
 - (Domestic Violence Shelter)- phasing out of their transitional housing Sept 1., calls are picking up in the shelter, non-emergency, EMS is only allowing the shelter to allow a certain number of people in based on number of bathrooms available in the shelter
 - o Stanly
 - (Emergency Shelter)- clients from shelter are accessing public housing as a resource
 - (Domestic Violence Shelter)

- o Union
 - (Emergency Shelter)- served 65 households, 125 individuals with Covid-19 response team, staff members trained to support and provide resources to people in need due to Covid-19, still isolating high risk populations, not at full capacity with shelter stayers, food pantry still open to anyone in the community in need of food
 - (Domestic Violence Shelter)
- <u>Salisbury VAMC</u>- some face to face appointments, workers doing things remotely, telehealth appointments
- <u>Volunteers of America</u>- housed a lot of veterans over the past 3 months, housing people in hotels still, things s opening back up has limited hotel access, some clients have been banned from shelters, challenges with housing people who don't make 2x rent requirements, working with property managers and private landlords has been tough, veterans against shared housing and with housing convicted sex offenders, not much housing available in rural counties, still taking referrals. Barriers with substance abuse treatment needed for Veterans also
- <u>Homeless Veterans Re-Integration Program</u>- active, enrolling Veterans virtually, plenty of training \$, new office potentially coming in the Salisbury area, here to service with no wait
