



LSA Reporting Correction Timeline

Event	Dates	Focus
DQ Wave 1:	09/14 – 9/25	 Data quality/completeness (demographics, homeless history, UDE's, etc.)
DQ Wave 2:	09/30 - 10/09	 Locations (Client Location and NC County of Service)
DQ Wave 3:	10/14 – 10/23	 Long stayers, Returns, and Annual Assessment errors
HUD 1 st Deadline	10/30	 HUD begins to review our CoC's data
HUD Submission	Rolling process	 Until the data is confirmed or corrected



Why continue cleaning?

LSA Impact

- HUD publishes our data to the world!
- Data Quality is judged by HUD for 'usability' in national analysis
- Points gained/lost in CoC Application
- Points determine ranking and \$\$\$



Communication is KEY!

- HUD is contacting us weekly with data reviews and questions
- We don't want to bother you if you've already reviewed something. Just let us know!



Report Corrections FAQs

How often should agencies expect updates?

• Once a week

What are we expecting from agencies?

• List of client issues reviewed, corrected, or confirmed

What are the possible responses to a list of corrections?

- It's corrected! (yay!)
- I cannot correct it. (confirmed)
- It looks correct when I look at this.

Timeline

Data is for FY2020 (10/1/19 – 9/30/2020)

• Reporting period includes data as far back as 10/1/2017

HUD's deadline for submission is March 1, 2021

- We've got to review and clean-up data ahead of this deadline.
- Length of Time Homeless, Returns to Homelessness, and Exit Destination are already in LSA corrections.



Timeline

Plan to begin corrections after LSA complete

- We anticipate fewer corrections given all the LSA work!
- We know the next three months will be busy.
- We will give as much review time as possible.
- Agencies should start and finish early!



- □ Has your team reviewed the data together?
- □ Have you made a program decision based on data?
- Do you have enough paper ROIs for the next month?
- □ Have you checked for Annual Assessments coming due?
