



### **NCCADV CoC Project**

#### Summary of NCCADV Safe at Home RRH Program

NCCADV is applying for the full \$2,099,582 DV Bonus Funds available to the NC Balance of State to implement a rapid rehousing program for survivors of domestic violence. Through the Safe at Home project, NCCADV will partner with 10 domestic violence service providers (DVSPs) to implement RRH at the local level. These 10 subrecipients will be chosen through a competitive RFP process and will be selected based on their experience and capacity to implement such a program in their county and the surrounding region. Overall selection will be based on the group's collective ability to provide coverage to the Balance of State. NCCADV has already begun outreach to the DVSPs within the Balance of State to assess interest in participating in the program and is scheduling conversations with those Executive Directors who have expressed interest. We will begin the formal RFP process once awarded. We anticipate a project start date of April 2022.


NCCADV will contract with both NCCEH and Safe Housing Partnerships to collaborate on trainings and technical assistance to each subrecipient DVSP. Trainings and technical assistance will include, but not limited to the following:

- Housing First principles
- DV rapid rehousing
- Removing barriers to permanent housing
- Using comparable database for CE
- Cultivating landlord relationships
- Additional services to support permanent housing

Through Safe at Home, NCCADV and its subrecipients will serve 400 households and 770 individuals with rapid rehousing and supportive services such as utility deposits, moving assistance and connection to other social supports such as food stamps, SNAP and health insurance/Medicaid. Safe at Home will fill a gap for many survivors experiencing homelessness and safety issues, who have been disproportionately impacted by the pandemic.
