



Outreach can look like:


- Assertive or Active Street Outreach is meeting folks where they are
- Passive outreach or "in-reach" is meeting folks at community events, other organizations, similar to past service counts
- Big groups covering a whole town or county
- Small teams of 2-4 people going out

Plan "street outreach days"

•

- Plan 1 "street outreach day" per month
 - Form teams with 2-4 people that can engage people living on the streets
 - Engage volunteers to be part of your teams
 - Work together for safety and coverage
 - Go out for 2-4 hours and focus on known locations
 - Communicate information to CE Lead

- Collect minimal information and focus on relationship building and connection
 - Bring incentives: gift cards, sock, snacks
 - Get contact information and ask them what they need
- Provide information and ask if you can schedule a time to talk further
 - At your service agency, if they can meet you there
 - At the place you met them
 - At a mutually agreeable place

Coordinate Passive Outreach

Identify partners that regularly serve people living unsheltered

- Food pantries
- Day centers
- Breakfast/lunch/dinner programs
- Crisis ministries
- Others

Connect with agency/program staff and ask if someone can come once a week to engage people living unsheltered

- Ask agency/program staff to help identify people for outreach
- Provide them information to connect people living unsheltered to you or other designated person to engage on non-outreach days

Take advantage of any upcoming events to engage people living unsheltered

- Thanksgiving or Christmas events
- Coat or other winter supply giveaways

Facilitate Follow-up


How can you reach folks after outreach?

- Call... more than once
- Email or any other contact info
- Visit their last known location

Next Steps

- Join SSO calls for planning support
 - If you haven't submitted, we will complete the worksheet together
- Email local volunteers and agencies with the plan
- Identify at least 3 Street Outreach Days a year
 - November, December, January

Emergency Housing Voucher

1) Households are ready to Move On with long-term rental assistance but less intensive case management. Permanent Supportive Housing (PSH) and Rapid Rehousing (RRH) clients are both eligible for Move On.

2) Households with highest length of unsheltered homelessness and where documentation for PSH (chronic homelessness and/or disability) is not able to be obtained.

3) Families and/or individuals on current regional Coordinated Entry (CE)

by-name list (BNL) who need long-term rental assistance.

EHV Roles and Responsibilities

PHA

- Accept referrals from CE Lead
- Comply with all HUD standards
- Conduct Briefing for voucher households
- Support households in housing search process
- Complete HQS
- Enter Housing Assistance Payment (HAP) Contract with Landlord
- May assist with other supportive services







CE Lead

- Main point of contact for the PHA
- Partner with PSH & RRH providers to facilitate moving on referrals
- Filter BNL for priority 2 & 3 during case conferencing
- Complete all EHV referral forms and send to PHA
- Identify a provider point of contact for each household



NC BoS Transfer Form

Purpose: Client chooses to live in a different region than where they are currently receiving services

Who should use it: Provider currently working with the household

Role of CE Lead:

- You will securely receive this form along with HMIS forms and VI-SPDAT assessment
- Enter the household into your regional CE project
- Case conference

Introduction to VA Health Systems

- Local VA Health Care Systems are overseen by the Department of Veterans Affairs, a Cabinet level executive branch of the federal government.
- Within North Carolina there are 4 main VA Health Care Systems:
- 1. Durham VA
- 2. Salisbury VA
- 3. Fayetteville VA
- 4. Asheville VA
- 5. Hampton Virginia VA
- These main VA's also have various satellite clinics, called Community Based Outpatient Clinics (CBOC's) and larger clinics called Health Care Centers (HCC's)
- Each VA has their own service area (also called a catchment area)

Durham VA Catchment Area: Balance of State Regions

- Region 6: Alamance, Caswell, Chatham, Person & Rockingham
- Region 7: Johnston
- Region 9: Edgecombe, Franklin, Granville, Halifax, Nash, Vance, Warren
- Region 10: Wilson, Greene
- Region 11: Hyde
- Region 12: Beaufort, Bertie, Martin, Pitt, Washington
- Region 13: Carteret, Craven, Pamlico

Role of Coordinated Entry Specialist

- Participate in CoC meetings and planning efforts which may include leadership roles within the CoC group
- Provide direct linkage from community services to VHA homeless program services through regular and consistent communication with community providers
- Participate in case conferencing process within the CoC's coordinated entry system to help inform and facilitate referrals to VA programs
- Participate in policy formulation with federal partners, including VA, HUD, and USICH who have active initiatives to promote CES and community planning. The incumbent will work with local VA programs to ensure broad-based participation in CES and community planning

Role of Balance of State CE Leads:

- 1. Share current By Name List, encrypted or password protected, monthly the Coordinated Entry Specialist
- 2. Share any contact information available for Veterans on the list; If available Social Security Number, as it will determine program eligibility criteria
- 3. Send referral to Volunteers of America, Carolina's Office

Tip: Utilize "Point of Contact" Forms that are available and disseminate to service providers.

Durham VA Health Care System: Homeless Program Service Highlights

- Outreach Services
 - 3 Social Workers serve the Catchment Area
- Transitional Housing Services
 - Volunteers of America, Maple Court- Durham NC
 - TROSA
 - HUDVASH
 - Section 8 voucher and intensive case management services for most severe veterans; not applicable for those with low income only, must have severe service needs
 - Not available in certain areas; Voucher can be used within 50 miles of Housing Authority
- Contracted Emergency Services
 - 12 Bed contract with USA Veterans Help, Durham NC
- National Homeless Call Center
 - (1-877-424-3838) 877-4AID VET



Staff celebrated the upcoming Thanksgiving holiday and break approaching.

Racial Equity Dialogue Debrief

Jeremy Ratcliff gave an update to the subcommittee on the Racial Equity Dialogue Series that took place on November 9th, 2021. A total of 146 people registered with 85 attending making it the most attended dialogue series to date. Feedback was very good from both panelist and participants noting that the conversation was "powerful" and "timely. A workgroup meeting will be called in December to discuss plans for dialogue series in 2022.



Anti-Discrimination Policy

Staff provided information on the NC BoS Anti-Discrimination Policy. Anti-Discrimination policy is currently focused on preventing overt acts of discrimination, largely in access to services. There is not currently much of an equity lens embedded in the policy. Subcommittee members expressed very little capacity to take on another work group, and Jeff proposed examining the anti-discrimination policy as a whole subcommittee. Staff will review the document and bring proposals to the subcommittee.

The RE Subcommittee has the opportunity to propose revisions to the anti-discrimination policy in early 2022.

Prioritization Work Group

Andrea Carey gave an update about the Prioritization Workgroup. Gave information about the HUD TA: Equity Initiative noting that NC BoS CoC was selected as one of 9 communities in cohort 2 and sessions have already begun.

• Andrea welcomed members and introduced the agenda for the meeting.

FPS Planning

- January How to find Active Clients (People Experiencing Homelessness in our System) for different geographic areas
 - PHA catchments for advocating for dedicated vouchers? (at PHA meetings, preferences long-term not just for special funding)

Outcomes Overview

Access to Permanent Housing (PH)

- **PH Exits** = a client/household was enrolled in a homeless dedicated project and left for a permanent destination (no longer receiving services)
- **Move-Ins** = a client/household began sleeping in a permanent situation but may still be receiving services (only recorded for CE, RRH, and PSH projects)

It was also noted in the data that we helped 3,358 individuals or 1,909 households find permanent housing over the last complete year (FY21).

HMIS Recruitment Update

 Andrea gave an update on the HMIS Recruitment and its resources. It was noted that Family Guidance Center recently determined to be able to join. Also provided feedback about where the system needed to focus its attention and one strategy would be to improve its move on strategies.

Subcommittee Admin

Group did talk about member recruitment efforts for 2022. Different strategies discussed to do another recruitment push. Members to review 2021 support materials for Regional Lead Alternates by end of year.
