- Coordinated Entry Update

- Rapid Rehousing Update
 - HERE will begin filling Rapid Rehousing slots at January's Referral and Monitoring Meeting
- Back@Home Update

- Those in need of assistance are now able to call 211 to be screened for the Back@Home Program. This screening will include an assessment of vulnerabilities with those with higher numbers receiving a higher priority.
- This program provides Homeless Prevention and Rapid Rehousing Financial Assistance.
 - Homeless Prevention the household must be in imminent risk of losing their housing in the next fourteen days without alternative housing identified **and** meets income requirements (<30% AMI).
 - Rapid Rehousing serves households meeting Categories 1 & 4 of HUD's definition of homelessness.
- Once HERE accepts the referral, the household will be assigned to a case manager who will begin working with the household directly to set up a case plan and begin looking for housing.
- Referral and Monitoring Meetings will be used to ensure that there are no duplication of services between clients.
- Permanent Supportive Housing Update
 - o 6 mnths through the grant year, just under 130k, just over 7k in admin, PSH western region spending is just under 41%, goal was 50%. Spending was down but that's because multiple members are currently homeless and looking for housing. 50 psh members, 39 in housing, 11 households looking. 99 individuals served, 68 adults, 32 children. Still waiting on referral for 51st household. Thinks one slot will become available in January.

OTHER AGENDA ITEMS

- PIT Count 2021
 - This year's Point in Time Count is scheduled for Wednesday January 27th.
 - This year's count will be significantly different in that it will rely heavily on the Coordinated Entry By-Name List as its primary source of unsheltered household data. Survey taking will be a secondary method. As such, we as a region will need to increase our Coordinated Entry outreach efforts between now and the time of the count.
 - Non-HMIS Shelters will be using the "Counting Us" app to conduct their count.

- Emergency Solutions Grant Coronavirus 2
 - Region 1 has been alloted \$638,536.00 in ESG-CV2 funding.
 - Housing Stabilization Minimum \$383,121
 - Emergency Response Maximum \$255,414
 - The final submission deadline is **January 22nd by 5 pm.** The regional coalition and Balance of State will have pre-approval deadlines before that time.
