- The Ark has their Cardboard City fundraiser at Elkin Park the 23rd of November.
- Shepherd's House will have an unveiling/ ground breaking on October 14th. They have also taken over Helping Hands in Mt. Airy.
- Alan suggested the landlord recruitment/appreciation event be put on the agenda next month.
- Bonnie suggested possible HMIS training due to VISPDAT entries will be made in HMIS in the near future. She also is looking for FEMA LIEAP, or other funding in Iredell, Yadkin and Surry counties.
