Directions to the Rockingham County Center for Economic Development, Small Business & Tourism at 425 NC 65, Reidsville, NC 27320.

We are directly across the road from Rockingham Community College.

**From PTI Airport**: Take 68N to Stokesdale, and continue on north as 68 merges into 220N. Follow 220N to Madison. Take the first Madison exit, which is Hwy 704, 65 and 220 Business, and go east to Wentworth. There is a big sign on 220 that says Rockingham Community College this exit. Follow 704 until it becomes 65 about 10 miles (rough estimate) to Wentworth, turn left into the Governmental Center parking lot.

**From Greensboro (Downtown):** Follow Battleground to 220N to Madison. Take the first Madison exit, which is Hwy 704, 65 and 220 Business, and go east to Wentworth. There is a big sign on 220 that says Rockingham Community College this exit. Follow 65 about 10 miles (rough estimate) to Wentworth, turn left into the Governmental Center parking lot.

**From Greensboro (East Side):** Take US 29N to Reidsville. Take the second Reidsville exit – Exit #149 (NC 87). Turn left at the light at the end of the ramp. Follow thru Reidsville until you see signs to Rockingham Community College and Hwy 65. Exit to the right and turn left on Hwy 65. Follow 65 to Wentworth and the Governmental Center will be on your right

**From Winston-Salem (I-40 East):** Take I-40 East towards Kernersville and exit on Highway 158 East; continue through Stokesdale. Follow Highway 158 road signs to Highway 220 North. Proceed on Highway 220 North and exit on Highway 704 East. Proceed on Highway 704; it will turn into Highway 65. Follow 65 about 10 miles (rough estimate) to Wentworth, and we are on the left in the Governmental Center.

**From Raleigh (I-40 West):** Take I-40 West towards Elon College. Take Highway 87 North to Reidsville. From Reidsville, travel Highway 87 North to Highway 65. Approximately 6 miles north of Reidsville, Rockingham Community College is located on the left and the Rockingham County Governmental Center on the right.

**From Martinsville, VA (Highway 220 South):** Travel 220 South and exit on Highway 704 East. Proceed on Highway 704 and it will turn into Highway 65. Follow 65 about 10 miles (rough estimate) to Wentworth, turn left into the Governmental Center parking lot.

**Meeting called to order** at 10:13 AM 3/22/18 by Ellery Blackstock.

**Present**: Mary Hughes and Jai Baker, Allied Churches, Kathleen Anderson, Family Abuse Services, April Durr, United Way of Alamance Co., Joel Rice and Karisa McDaniel, Cardinal Innovations, Natasha Elliott, Central Piedmont Community, Amanda Beckwith and Ginny Rainwater, Community Link, Donna Moye and Jackie Lucas, Salvation Army and Ellery Blackstock, Rockingham Co. DSS.

**Welcome and Introductions**: Ellery asked everyone to introduce themselves and what agency they represent and thanked everyone for attending. Thanks to United Way of Alamance Co. for hosting this meeting.

Minutes reviewed as sent out via email.

Discussed agencies to volunteer to host the upcoming in-person meetings for the remainder of the year. The results are as follows: May 24 is open, September 27<sup>th</sup> – Cardinal Innovations Alamance and November 29<sup>th</sup>-Central Piedmont Chatham Co.

Discussed the Supportive Services Only-Coordinated Entry Grant: SSO grantees will become the CA leads for their Region. NCCEH will release application materials in a detailed RFP in April for an application due date in May. Ellery stated that since Thadeous Carr of Allied Churches has been the PRACC's CA Lead and has done a great job; he would continue to represent the PRACC Region well if they applied. Jai Baker of Allied Churches stated that Allied Churches was preparing on applying for the grant. Ellery said that it was open but whoever applied had to be the lead for the five county

Region. Natasha Elliott made a motion that Allied Churches apply for the SSO grant and it was seconded by Joel Rice. There were no questions and the motion; Allied Churches was voted on to apply for the SSO grant when it comes out.

Discussed the PRACC Sub-committees and explained that on these committees, we are looking for at least 3 members per committee and you may be on multiple committees. The committee would meet once a month within the first two weeks of each month; via in person or conference call. Once the committee gets together, they could establish who would lead that particular committee and report back to the general committee/region. As of this day we have the following signed up for a committee:

There was discussion about the committees and how they will operate. Would there be guidance from Balance of State, ESG office and from each county about the responsibilities and governance of the committees and the answer was yes; all would be true as well as lesson's learned from each county. We would use best practice from them all to develop what works best for the PRACC. We could be very creative and work efficient to prevent burn-out as everyone has a lot on their plate of things to get done.

# **Agency Updates/Spot light:**

Natasha of Chatham stated that Jai Baker and staff will be coming to Chatham County to share with them the Coordinated Assessment and how it works. Chatham has placed their first Rapid Re-Housing client into housing. They continue to have some issues such as affordable housing, not enough landlords and rent, etc...

Jai of Alamance Co. stated that they will have their 4<sup>th</sup> annual landlord breakfast on the 29<sup>th</sup> of March and looking for a good time. Also they have completed their first HUD audit and it went pretty good. There were no findings so far. They looked at ESG, CofC and HMIS and they had all three to be audited.

Jackie of Salvation Army- Greensboro, they are expanding and assisting Chatham County with prevention services. They first had about 40 people for prevention services and now have grown to about 200. They are also getting ready to start using the HMIS. Glad to be a part of Region 6.
