7. Permanent Supportive Housing

- No updates
- All housing slots are filled
- COC renewal was submitted and granted for renewal

8. B@H Program COVID

- Cicely Pighet provided update for Back at Home
- 211 remains closed for Back at Home
- 384 people have called into 211 for our counties
- Have enrolled 141 individuals/families at this time
- Currently have assisted 69 individuals/families
- 70 people in housing search
- Two folks to self-resolve
- Over 170 families have been contacted
- 8 plus people to make contact with at this time
- Anna Register is assisting on intakes
- Stephanie Edwards, case manager for Scotland County
- Encouraging assistance with finding additional landlords due to shortage of housing

9. Rapid Rehousing Program

- Recently noticed an increase within referrals for the program.
- Currently housed 29 families for the year
- 4 families were not able to sustain housing for various reasons
- Still accepting referrals
- Encouraging others to refer landlords to the program

10. HUD VASH/ Veteran Services Update, Carla Clark

- Lumbee Tribe has been awarded additional 20 housing choice vouchers for Tribal HUD-VASH
- Time and Criteria for eligibility discussed. Required time served is no longer a criteria to meet.
- Able to assist Veterans that are honorably discharged and other than honorable discharged based on DD-214.

11. Coordinated Entry/Assessments

- Coordinated Entry Preauthorization Committee (Latasha McNair, Jamonica Watson, Hollie Oxendine, April Leake, Denise Riggins, Allie Card) met to discuss how to better assist individuals through coordinated entry. Prioritizing through scoring/case conferencing
- Addendum to the VI-SPDAT to be developed for case conferencing
- Motion to approve the Coordinated Assessment amendment as Hollie read by Emily Locklear. Motion moved to accept the protocol by David Edmund, 2nd motion provided by Denise Riggins.
- Coordinated Entry Document will need to be in a secure database as required by HUD.
