


# **Group Agreements**

# **CoC Defined**


At its simplest, a Continuum of Care is established by *representatives of relevant organizations* within a *geographic area* to *carry out the responsibilities* set forth in the CoC Program interim rule.




## **12 CoCs exist in North Carolina**

# NCCEH's role

NCCEH is the NC BoS CoC's Collaborative Applicant and HMIS Lead

- Staffs the CoC
- Facilitates the CoC and ESG competitions each year
- Ensures the CoC meets HUD requirements
- Provides training and technical assistance for best practices and HMIS
- Serves as grantee for HMIS and SSO CE

# **Coordinated Entry System**

#### HUD definition of Coordinated Entry (24 CFR 578 – CoC)

- Coordinated entry systems allow CoCs to coordinate program participant intake, assessment, and provision of referrals. The system covers a set geographic area, can be easily accessed by individuals and families experiencing homelessness or at-risk of homelessness seeking housing and services, is well advertised, and includes a comprehensive and standardized assessment tool
- All CoC and/or ESG-funded agencies are required to participate in Coordinated Entry



## **Core Elements of Coordinated Entry**

Access: CES is easily accessed by individuals and families seeking housing or services.



comprehensive and standardized assessment tool (currently the Vulnerability Index – Service Prioritization Decision Assistance Tool ,



Prioritization: CoC uses the CE process to prioritize persons within the CoC's geographic area and is based on a specific and definable set of criteria.



Referral: CoC- and ESGprogram recipients use the coordinated entry process as the only referral source from which to fill vacancies.



## **NC BoS CoC Coordinated Entry**

#### **BoS Coordinated Assessment Vision Statement:**

Coordinated assessment assists the NC BoS CoC to end homelessness by increasing exits to housing, decreasing length of time homeless and reducing returns to homelessness. Consumers will quickly access appropriate services to address housing crises through a right-sized, well-coordinated agency network.



# **NC BoS CE Roles**

#### CE Lead

- Facilitate conferencing meetings at least twice each month and ensure all required agencies are informed of date and time
- Manage HMIS BNL
- Ensure households are served in order of priority

#### Housing Providers

- Participate in case conferencing meetings
- Fill open housing slot with households from BNL


#### Front Door Providers

#### • Review BNL

- Participate in case conferencing meetings to ensure households are being identified and connected to PH and services
- Support households through the PH process





# **Veteran Services in NC BoS**

- Veterans eligible for VA homeless services are connected to care as quickly as possible and rapidly assigned to an intervention that will assist them in resolving their homelessness. While VA funded programs are allowed to conduct assessments and make direct placements into homeless assistance programs, this must be done in collaboration with the CoC. SSVF providers are encouraged to work closely with CoCs and the CE process to establish screening practices that facilitate rapid referrals when Veteran households present for services. - Coordinated Entry is one of many points of access to housing for Veterans facing a housing crisis and is a vital system to integrate with to meet Veterans' needs.





#### Dedicated Funding for Homeless Veterans has Increased Dramatically Since 2010




Annual federal homeless veterans program funding



#### **Exits and Returns**




## 2021 NC BoS HMIS Data
