




- Listen Actively respect others when they are talking (step up, step back)



BoS Veteran Point In Time Count (2011 – 2022)



50% overall decrease in Veteran homelessness across the NC BoS CoC between 2012 and 2022.

- 78% decrease in unsheltered Veteran homelessness
- 42% decrease in sheltered Veteran homelessness


*2021 PIT count did not include an unsheltered count.

- Average monthly Outflow = 45 households






Table 9: NC Balance of State CoC Populations: Veterans-Race (HUD Tool)

- 17% of Veterans in North Carolina identify as Black/African American
- 42% of Veterans counted in the 2021 Point in Time Count identified as Black/African American



- Of the 870 Active Veterans 49% were Black/African American; 47% were White
- Of the 333 PH Exits 53% were Black/African American Veterans; 42% were White
