#### I. Introductions

- a. Name, Where from, Accomplishments with SOAR this month
  - i. Aundry Freeman- Asheville- Good meeting with SSA office this month
  - ii. Violet Collins- Pitt County- 1 person approved for SSI
  - iii. Brooks Ann McKinney- Wake County- getting community onboard with program, working on 2 cases, 2 interns joined Brooks Ann
  - iv. Spencer Cook- Durham- Productive meeting with SSA office to work out kinks
  - v. Elizabeth Lumley- Durham- Meeting with SSA office, continuing good relationship with SSA
  - vi. Kathryn Winston- Yesterday had unexpected approval, based on Medical Summary Report
- b. Kristin Lupfer from Policy Research Associates
  - i. Senior Project Associate for the SOAR TA Center
  - ii. Former director of Georgia's SOAR program
  - iii. TA provider for NC

### II. National Perspective on SOAR

- a. Update from Kristin on current SOAR Initiatives
  - i. Policy Highlights- from work with SSI Taskforce with National Healthcare for the Homeless
    - SSA preparing reports about open comment period for issue of materiality of drugs and alcohol to disability listings
      - a. SSA received conflicting comments
      - b. Emily to email link to comments to SOAR Dialogue Group
    - 2. SSA work with the USICH Plan to End Homelessness
      - a. SSA looking at how to increase/better outreach efforts which includes SOAR
      - b. SSA looking at how to make transition easier for children who receive SSI benefits
    - 3. Emphasizing flagging and expediting "Homeless" cases
      - a. "Transient" flag within SSA system for individuals who are "doubling up"
      - b. "Transient" flag not followed through consistently at SSA offices
    - 4. Advocating for training for SSA/DDS staff about working with homeless individuals
    - 5. Growing the number of states using SOAR Process

- a. 6 regional offices are onboard with SOAR Process
- b. Emily clarifies that SOAR Process is the use of the initial fax form to develop a PFD and 60 day window to submit applications
- c. Atlanta Regional Office is not onboard with SOAR Process
  - i. NC only state in region with this onboard
  - ii. SC to start using SOAR Process in September
- 6. Advocating for a "SOAR" Flag in national SSA System
  - a. Easily identifies SOAR cases in system
  - b. Going to take time to advocate for this change
- 7. Advocating for expanding the list of acceptable medical sources
  - a. Homeless individuals do not always see doctors and Ph.D. psychologists for treatment
  - b. Want to include LCSW, NP, PA signatures as medical evidence
- 8. Bill currently introduced in House to increase the resource limits for SSI applicants
  - a. Allows for applicants to have retirement accounts, savings
  - Would prevent individuals from having to "spend down" resources
- 9. Questions on Policy
  - a. In reference to open comments about drugs and alcohol- can comments be regulated?
    - i. Problematic when SSA gets wildly different opinions
    - ii. SSA weighs opinions of experts more heavily
  - b. Homeless Definition with SSA- would someone with a Shelter plus Care voucher be considered homeless?
    - i. Would not be considered homeless if in apartment with voucher
    - ii. Living arrangement would depend on SSA categorizing the voucher, check with the local SSA office
  - c. Can you clarify "Transient" Flag?
    - i. Created in September 2009
    - ii. Not consistently used

  - 1. Information about having your agency become an Organizational Payee
  - 2. Document explaining HIPAA FAQ to medical records departments
  - 3. Information about states and local laws that mandate medical records be provided for free for disability applications
    - a. NC does not currently have these laws in place
    - b. Opportunity for advocacy in NC
  - 4. PATH/SOAR Collaborations Paper
  - 5. Issue brief about working with AmeriCorps programs
  - 6. PowerPoint available on funding and sustainability available

- 7. Hospital Collaboration Toolkit
  - a. PowerPoint presentation
  - b. Sample MOU

  - a. HRSA Grants: Is SOAR included in their expanded list of programs that can be funded?
    - i. Not specifically listed
    - ii. Can be funded through Medicaid as part of case management in some states
  - b. SOAR wants to start topical webinars what topics would be useful to cover?
    - i. Working with hospitals
      - Wake and New Hanover Counties are having difficulty with hospitals referring individuals to private organization for applications
      - In Atlanta, able to make agreement with Grady Hospital to refer all homeless individuals to SOAR
    - ii. Developing relationships with SSA offices
    - iii. Educating doctors about SOAR
    - iv. Educating Caseworkers about recognizing and evaluating cognitive disabilities
    - v. Email Kristin with any other ideas (klupfer@prainc.com)
- b. National SOAR Outcomes (last year)
  - i. 3,158 Approvals
  - ii. 71% approval rating
  - iii. 89 days average decision time
- c. How NC compares with other SOAR States
  - i. Outcomes
    - 1. Last year: 40 approvals, 75% approval rating, 120 days
    - 2. This year: 108 approvals, 77% approval rating, 113 days
  - ii. Program development
    - 1. 13 FT dedicated SOAR caseworkers
    - 2. 5 PT or volunteer SOAR caseworkers
    - 3. 8 counties with active workgroups
    - 4. From 2006-2010: 29 trainings, 18 cities, 993 attendees
    - 5. Collaborations with hospitals, medical records departments, and training for physicians (Documenting Disabilities)
    - SOAR Caseworker Certification- national certification that models NC system
- d. Questions:

- i. Any attorneys using SOAR in pro bono work?
  - 1. Some programs that receive funding through grants and outside sources:
    - a. Philadelphia
    - b. Milwaukee
    - c. California
  - 2. There are a lot of law school students not being hired as interns could we develop a clinic with law interns doing SOAR applications with a supervising attorney?
    - a. Emily to speak at meeting of NC Disability Attorneys in December and propose idea in presentation
    - b. Emily to further explore this option

- a. Ann Griffin Hall stated that the faxing system is going well so far
- b. Feedback from the field about new process (faxes/examiners)
  - i. More awareness in DDS about SOAR
    - Aundry- DDS worker called her and stated that they would wait for records to make decision
    - Kathryn- DDS worker called her and stated they would wait for the Medical Summary Report to make decision
  - ii. Please provide Emily with ongoing feedback about the DDS system using specific case information
    - 1. Do not email identifying information
    - 2. Send email to Emily about incident
    - 3. Emily will follow up with phone call

- a. Group agrees would be helpful for NCCEH to compile list of medical records departments based on SOAR Caseworkers throughout the state

- a. Linda received letter that SSI was denied for applicant because Linda stated that the applicant did not want to file
  - i. Linda took applicant to SSA office to file application
  - ii. Linda believes is automatic letter generated
  - iii. Other Caseworkers had not received this type of letter
  - iv. Linda to check with local SSA office as to why she received the letter and how to avoid these letters in the future
