 - Data entry
 - Annual reports
 - Resources available



Data Quality Subcommittee Reboot

- Format
 - User-friendly
 - Practical
 - Retain Tip of the Month
- Proven results
 - DQ cleanup → change in housing stability stat
 - 2012 CoC App: 35% exits from PSH unknown
 - 2013: decreased to 15% unknown
 - 2013 housing stability rate 93%

Tip of the Month

- APR data must match CHIN data
 - HUD regulation
 - Makes common sense as well
 - Data tells the story of our work
 - Cannot do this if inaccurate
- Only 8 of 33 renewal grant APRs matched CHIN
- Be sure to go back to CHIN, make changes, re-run APR
- Time lag in CHIN

Review of No Fee User License Policy

- NC BoS has paid CHIN license fees for all existing CHIN users within Balance of State for July 1 2013 June 20, 2014. In order to maintain this no-fee license, users must:
 - Log in at least once every 60 days
 - Maintain an HMIS rating of 80 or higher (as determined in the Monthly Data Quality report) or be actively working with CHIN to improve HMIS rating
 - Be responsive to outreach from CHIN and/or NCCEH
 - User or other agency representative must regularly participate (80% or better attendance) in his or her local Balance of State Regional Committee meetings
 - Enter all HUD required elements in CHIN



No Fee User License Policy

- Potential revision by Steering Committee
- Implementation has begun
- Individualized plan for improvement to keep license
