NCCEH Update

Dear partners,

As many of you know, North Carolina's Homeless Management Information System (HMIS) is undergoing significant changes. The administrative agency that runs the HMIS is transitioning from the NC Housing Coalition to the Michigan Coalition Against Homelessness (MCAH). This will mean a new structure for our statewide HMIS implementation, new reports and workflows, and new ideas about how to use HMIS to end homelessness in North Carolina.

Under MCAH's model, instead of having a centralized HMIS staff that serves the whole state, Continuums of Care will have their own System Administrators. NCCEH will house system administrators for several CoCs and will soon announce these new partnerships. We're hiring for three of these positions now - please check out the job descriptions below.

We are also hiring for a Data Director who will focus on using HMIS to improve program performance, educate funders and community partners, and develop data-driven solutions. MCAH is also hiring a coordinator to lead their work in NC.

The CHIN Governance Committee published an FAQ at the end of January and is hosting a call for agencies on February 26th.

While change on this scale is always challenging, we are excited about the many opportunities it brings to help us reach our goal that homelessness will be rare, brief, and non-recurrent. We look forward to growing our team and working with communities to use data to end homelessness.
