Coordinated Assessment

Coordinated Assessment plans are in process of development & implementation

- Expecting 26 plans
 - 19 plans reviewed by CAC
 - 9 approved by Steering Committee/implementing
 - 4 recommended for approval after changes
 - 6 will be re-reviewed
 - 7 plans for initial review
 - 4 in process of passing threshold
 - 3 working on initial submission



There is one plan for Steering Committee review this month: AHRMM

- Positive points from CAC review
 - Good coverage for prevention & diversion screen
 - Thoughtful responses re: connecting to resources
 - Thorough grievance processes
 - Good example of oversight process

CoC Grant Competition Update

FY 2015 CoC Grant Competition activities continue

- HUD Headquarters finalized the Grant Inventory Worksheet (GIW)
- NCCEH staff submitted CoC registration
 - NCCEH as collaborative applicant
- Next steps
 - HUD will release Notice of Funding Availability (NOFA)
 - Expected in June
 - HUD provides competition details in NOFA
 - Funding landscape
 - Timeline



2015 Scorecard Committee began work on new and renewal scorecards

- Revised timeline with additional Steering Committee meeting
 - Tues. June 16, 1-2:30 p.m.
 - Discuss and potentially approve scorecards
 - If Regional Leads are current or potential grantees, they have a conflict of interest
 - Regional Leads and alternates without conflicts of interest can vote on funding issues, including scorecards



It's time for Regional Committees to appoint Project Review Committee members

- Responsibilities of Project Review Committee
 - Reviews and rates each project application according to the current scorecard
 - Recommends ranked list of project applications to the Steering Committee
 - Project applicants may not serve on this committee
 - Good to have someone with experience, homeless/housing background to make these important decisions
