Grant and Per Diem (GPD)

- Maple Court Veterans Transitional Housing Program is located at 207 Commons Boulevard in North Durham, NC.
- Funded through the United States Veterans Administration
- Working in collaboration with the Durham VAMC since 2009
- 24 apartments/beds
- Provides supportive housing and supportive services
- The goal helping homeless Veterans achieve residential stability, increase their skill levels and/or income.
- GPD change of scope for VOAC



Supportive Services for Veteran Families (SSVF)

- Rapid rehousing and prevention
- 27 Counties in NC - Alamance, Caswell, Chatham, Durham, Franklin, Granville, Harnett, Johnston, Lee, Person, Orange, Randolph, Rockingham, Wake, Bertie, Edgecombe, Martin, Nash, Northampton, Halifax, Hertford, Pitt, Vance, Warren, Washington, Wayne, and Wilson counties.

10/14 - 9/15: Cat. 1 (**Prevented from homelessness**) 48 Veteran Households

Cat. 2&3 (**Rapidly Rehoused**) 97

10/15 - 9/16: Cat. 1 (**Prevented from homelessness**) 58 Veteran Households

Cat. 2&3 (**Rapidly Rehoused**) 144 Veteran Households

10/16 - 9/17: Cat. 1 (**Prevented from homelessness**) to date 15 Veteran Households

Cat. 2&3 (**Rapidly Rehoused**) to date 26

Total to date: 388 households
