1. BoS Steering Committee meeting highlights, Nicole Dewitt, Community Link

- HUD outlined its anticipated timeline for this year's and subsequent competitions

 - c. 2017 Point-in-Time Count and HIC
 - PIT Count and HIC information was due to BoS staff on Friday, February 17.
- BoS staff will review PIT/HIC data and contact agencies about incomplete/inconsistent numbers; very high or very low numbers; changes to the program (bed inventory, program type) in March and April.
- BoS staff will submit data to HUD by the deadline of May 1 and post BoS data on the NCCEH website.

2. PRC Coordinated Assessment, Ginny Rainwater, Community Link

- a. PRC Updated Coordinated Assessment plan due on April 1, 2017. Coordinated Assessment has been operational in the Piedmont Region for one year. A new VISPDAT process was recently implemented using a google sheet. Since February 1, 2017,
 - i. 45 HH's have scored for no housing intervention
 - ii. 105 HH's have scored for Rapid Rehousing
 - iii. 16 HH's have scored for Permanent Supportive Housing

Programs Summary

Department: HUD Homeless to Housing

Service areas: Mecklenburg, Cabarrus, Stanly, Rowan, Union, Davidson, Gaston, Iredell, Lincoln, Chester, Lancaster, and York counties.

Programs: Permanent Housing, Rapid Re-Housing, Homeless Prevention, City Relocation, HOPWA

Homeless Definitions:

Category 1: Literally Homeless – Individual or family who lacks a fixed, regular, and adequate nighttime residence, meaning

- Has a primary nighttime residence that is a public or private place not meant for human habitation:
- Is living in a publicly or privately operated shelter designated to provide temporary living arrangements (including congregate shelters, transitional housing, and hotels and motels paid for by charitable organizations or by federal, state and local government programs); or
- Is exiting an institution where (s) he has resided for 90 days or less and who
 resided in an emergency shelter or place not meant for human habitation
 immediately before entering that institution.

Category 2: At Imminent Risk – Individual or family, who will immediately lose their primary nighttime residence, provided that:

- Residence will be lost within 14 days of the date of application for homeless assistance;
- No subsequent residence has been identified; and
- The individual or family lacks the resources or support networks needed to obtain other permanent housing

Category 4 – Fleeing and/or attempting to flee Domestic violence – Any individual or family who:

- Is fleeing, or is attempting to flee, domestic violence:
- Has no other residence; and
- Lacks the resources or support networks to obtain other permanent housing.



Housing Opportunity for People With AIDS (HOPWA)

Counties served: Mecklenburg, Cabarrus, Stanly, Rowan, Union, Davidson, Gaston, Iredell, Lincoln, Chester, Lancaster, and York counties.

- Category 1, 2, & 4
- o Individuals and families
- o Customer does not have to be homeless to receive services.
- o Income must not exceed 80% of AMI
- o This program covers 10 counties with three of them being in South Carolina
- Referrals can come from a variety of providers and self-referrals (Referrals do not have to come from Coordinated Assessment.
- We must have proof of HIV or AIDS status
- Allowable Expenses Security deposit, first month's rent, or utility deposits
- o Program Period this program is short-term 9 months max.
- City Relocation
 - o County served: Mecklenburg
 - o Individuals and families
 - o Income must be between 30-80% AMI
 - o Must not be in eviction status
 - o Referrals come from the City of Charlotte
 - Inspectors go out to a call from a resident about issues with their unit.
 - Inspector deems the house not habitable and refers them to Community Link for assistance.
 - o This program is only in Mecklenburg County
 - o Program Period short-term
 - Allowable Expenses Movers, storage, hotel stay for up to 3 weeks, security deposit, and first month's rent.
