Cardinal Innovations Grant Transfers

Cardinal Innovations is seeking to transfer CoC grants

- Cardinal CoC grants total \$2.13 million
 - Represents 26% of the NC BoS CoC portfolio
- Grants cover counties in Regions 5, 6, and 9
- Mike Bridges, who oversees Cardinal's CoCs grants, will update the Steering Committee on the transfer status

Governance Charter Update

The BoS governance charter is being updated to reflect changes in 2017.

- The charter was last updated in December 2016 (annual update is required by HUD)

- Staff Roles:
 - Removed reference to CoC pre-application

- Throughout:Used "NC BoS CoC" as abbreviation

2018 Point-in-Time Count & HIC

The 2018 PIT & HIC will be held the night of January 24.

- Point-in-Time Count = people experiencing homelessness
 - Emergency shelters
 - Transitional housing
 - Unsheltered situation
- Housing Inventory Count = homeless programs
 - Emergency shelters
 - Transitional housing
 - Rapid re-housing
 - Permanent supportive housing



Regional Committees should begin planning early.

- Create a PIT/HIC committee
- Choose PIT/HIC lead(s)
- Involve all relevant stakeholders in planning process
 - Programs that need to do sheltered PIT count (ES,TH, RRH, PSH)
 - Veteran service providers
 - Youth service providers
 - Homeless / formerly homeless people
- Send PIT/HIC lead's contact info to bos@ncceh.org by Friday, November 17



NCCEH will provide PIT/HIC forms and training.

- NCCEH creates forms for collecting data
 - Use 2018 HUD guidance
 - All RCs should use NCCEH forms please do not create your own
 - Forms will be posted at <u>www.ncceh.org/pitforms/</u>
- NCCEH provides trainings on the forms & general PIT/HIC guidance
- Regional Committees provide local training
- Forms & training info will be sent to RC PIT/HIC leads
