SSA Updates

COLA INCREASE:

Beneficiaries will see a 2.8% increase in their monthly payments beginning this month

Recipients with my SSA accounts can view their COLA notices online

The 2.8% adjustment is expected to boost average monthly payments by about \$56

SGA Amounts:

The monthly SGA amount for statutorily blind individuals for 2026 is \$2830. For non-blind individuals, the monthly SGA amount for 2026 is \$1690
