We can fax your key medical record information to another care provider upon your request the same day or prior to your scheduled appointment (At no charge)

Your records will be processed within 3-5 business days upon receipt of your completed form. (You will be invoiced upon receipt from HealthPort Copy Service.)

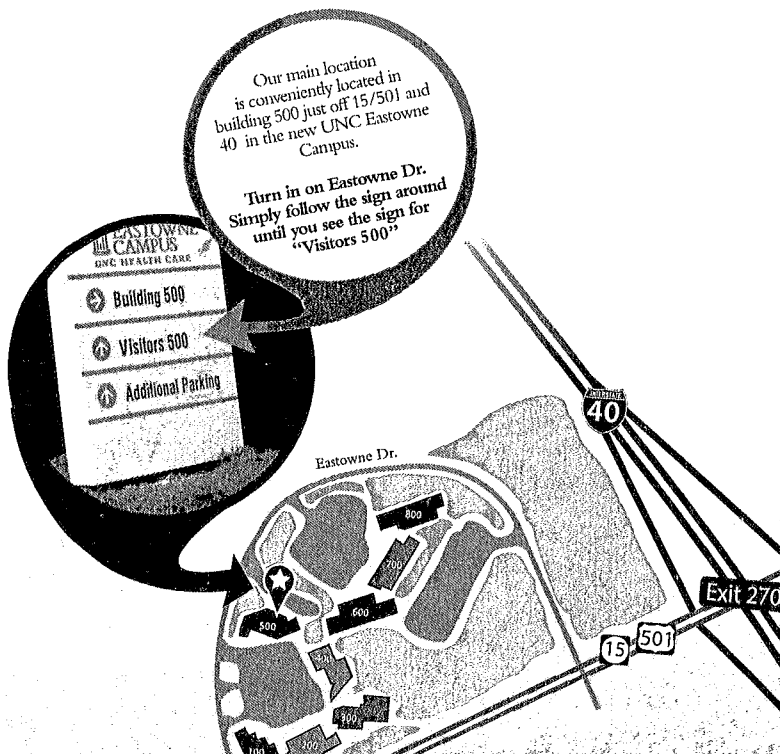

Personal Injury Case
Start to Finish

Personal Injury- PI cases are when an individual is involved in an accident (auto, slip and fall, etc.) that is due to another individual's negligence. *we typically only take auto accidents*

- After client comes in for an appointment, we will open and set up a file.
- assign office file number and put in Amicus
- Contact At-fault Insurance Company and set up claim OR if claim has already been set up, get Adjuster's information and claim number
- Contact Client's Insurance Company to set up Med-Pay.
- Send Letter of Representation to Insurance Company (At-fault and Med-Pay)
- Request Medicals for any initial medical treatment.
- Set up claim with Health Insurance
(you can do this in the beginning or end, sometimes it is best to set up once you know health insurance has made a payment on bill)
- Once client is done treating, need to verify all medical facilities client treated with and make sure we have medicals in file. If we don't, send out request for medicals.
-some medical requests will be done on chartswap, Mr. Retriever, via fax, or mailed
- After all medical billing and records are collected in file. Prepare demand letter
- Mr. Rowland reviews demand letter and after changes are made, we send demand package to client.
client should receive an approval letter to sign and return back to us and also the initial letter to client with demand package
- Client reviews demand package and once they approve package, we send the package to the Insurance Company
(be sure to get signed approval letter from client and put in our file)
- We give the Insurance Company 30-45 days to review the claim.
- Prior to receiving offer; Contact Medical Providers to check balances
- Once we receive the initial offer from adjuster, inform MCR, ask for counter and then inform client of first offer and suggested counter. Once client gives permission for a counter call adjuster or have MCR call adjuster and make approved counter
- The negotiation process goes back and forth 3-4 times before the Insurance Company give us their final offer
- Inform client of final offer and settlement breakdown (at this point, verify all balances)
-If health insurance has paid on any bills hold money aside for health insurance lien
health insurance will more than likely want to get reimbursed for what they paid out
- If client accepts offer, contact Insurance Company and accept final offer
- Insurance Company will send the check and release
- Prepare Settlement Proceeds Letter
-if it is on a minor be sure to use settlement proceeds letter for a minor
- Once we receive check and release, contact client and set up time for client to come sign.
- Give book keeper the Summary of Medical Balances to cut all checks
-once checks have been cut be sure to make two copies of all checks, one set will go to client with "copy" stamped while the other set will go in our file

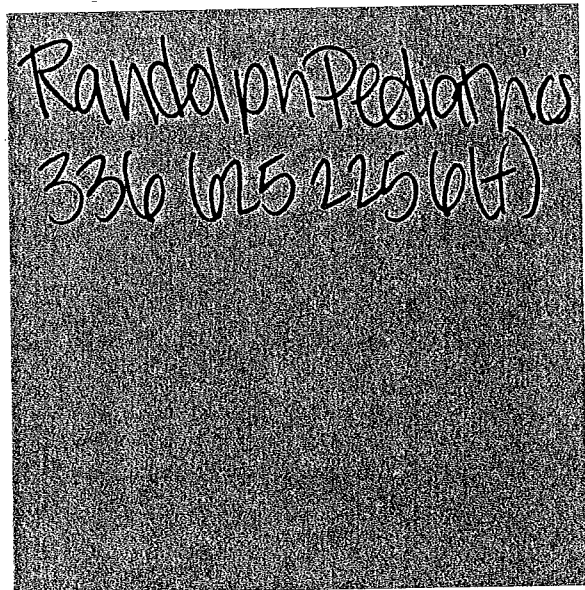
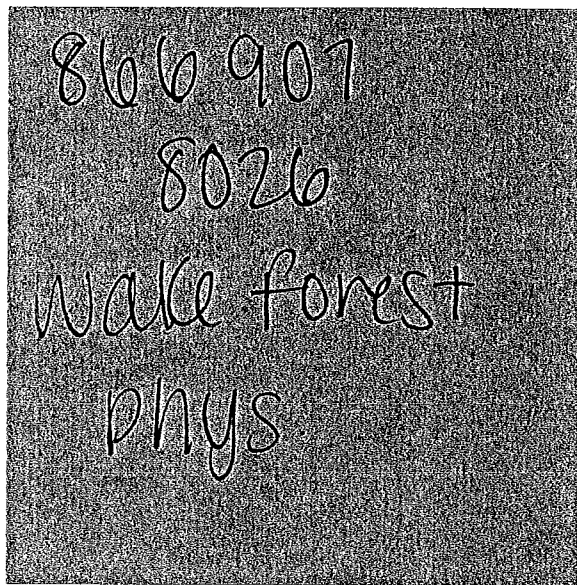
