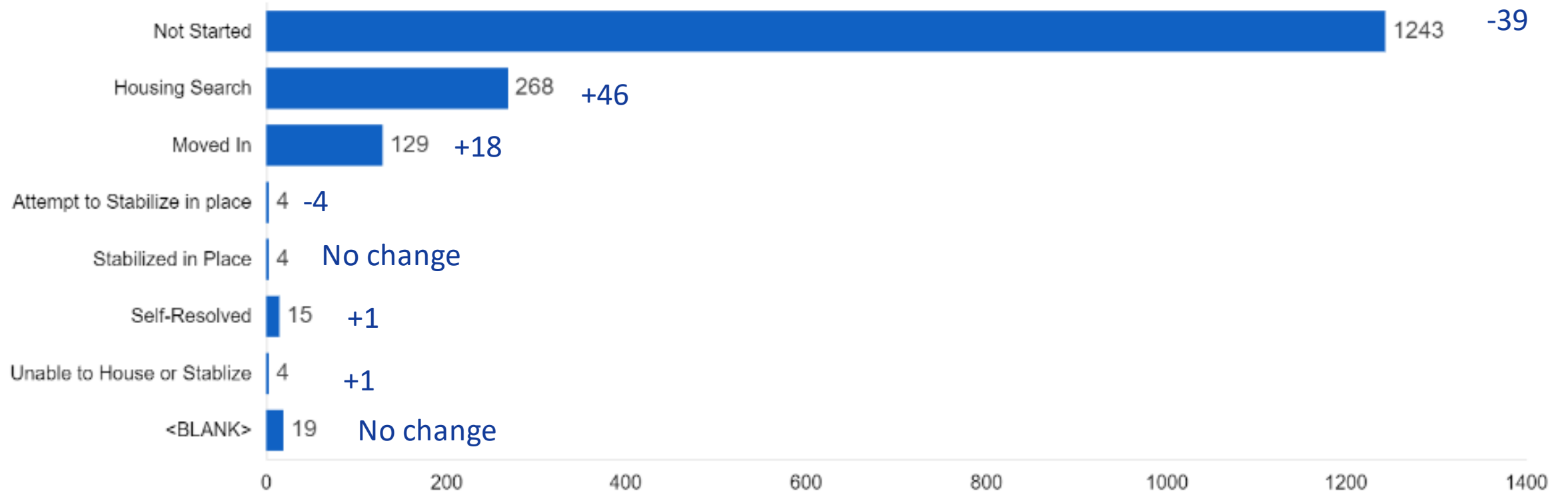

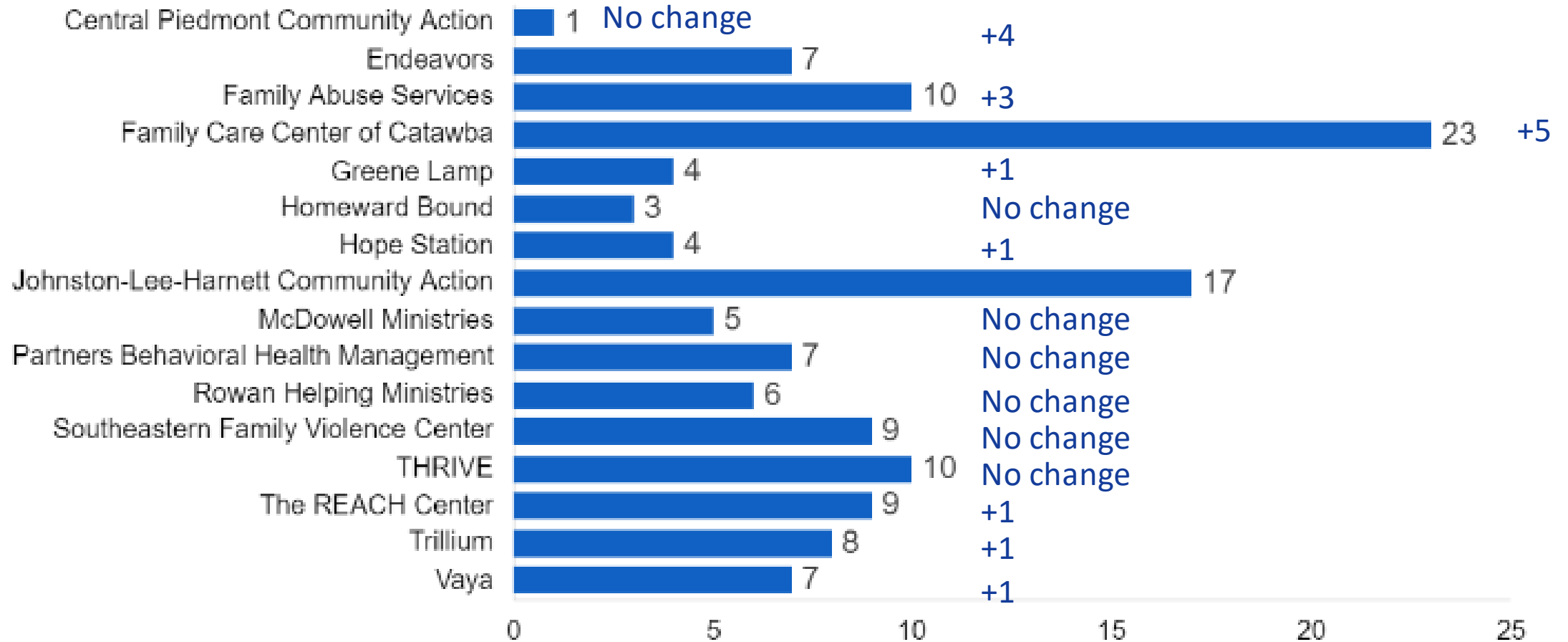

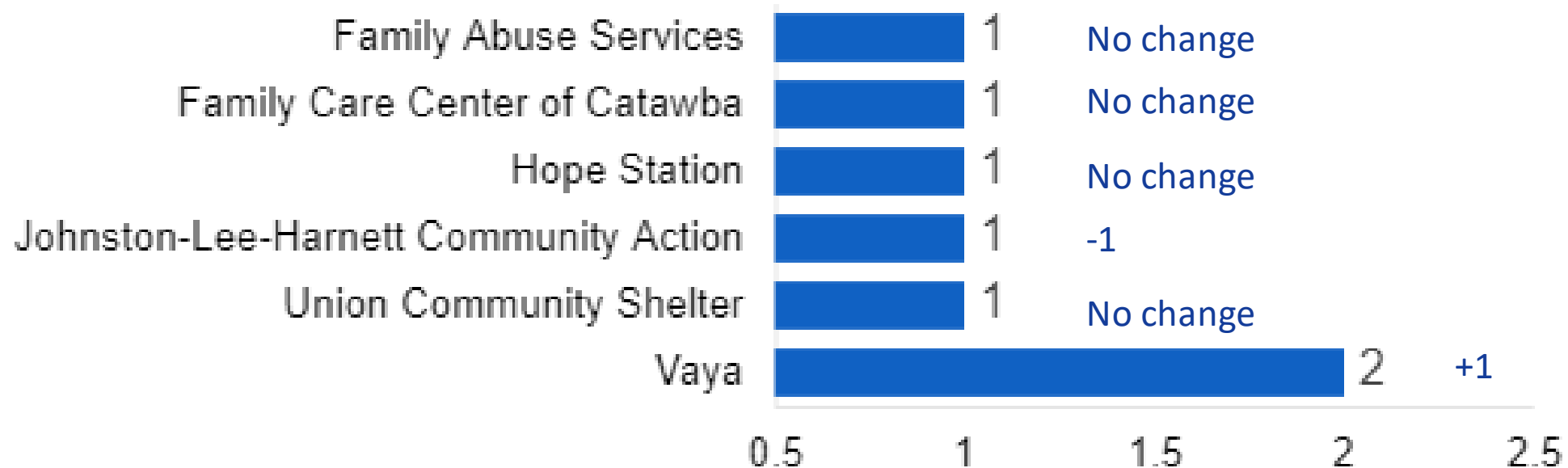
Housing Stabilization Status



Moved-In Households by Rehousing Agency

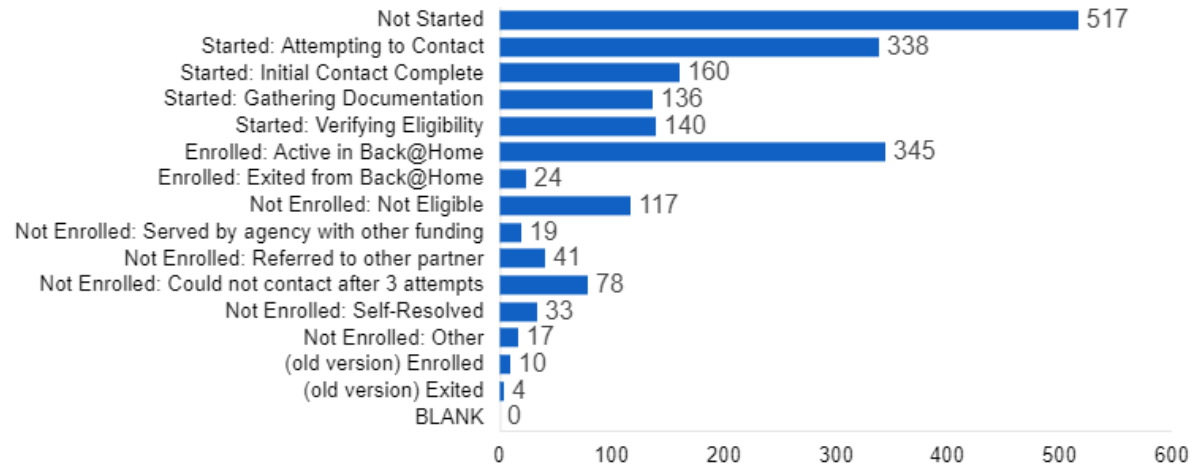


Stabilized in Place Households by Rehousing Agency

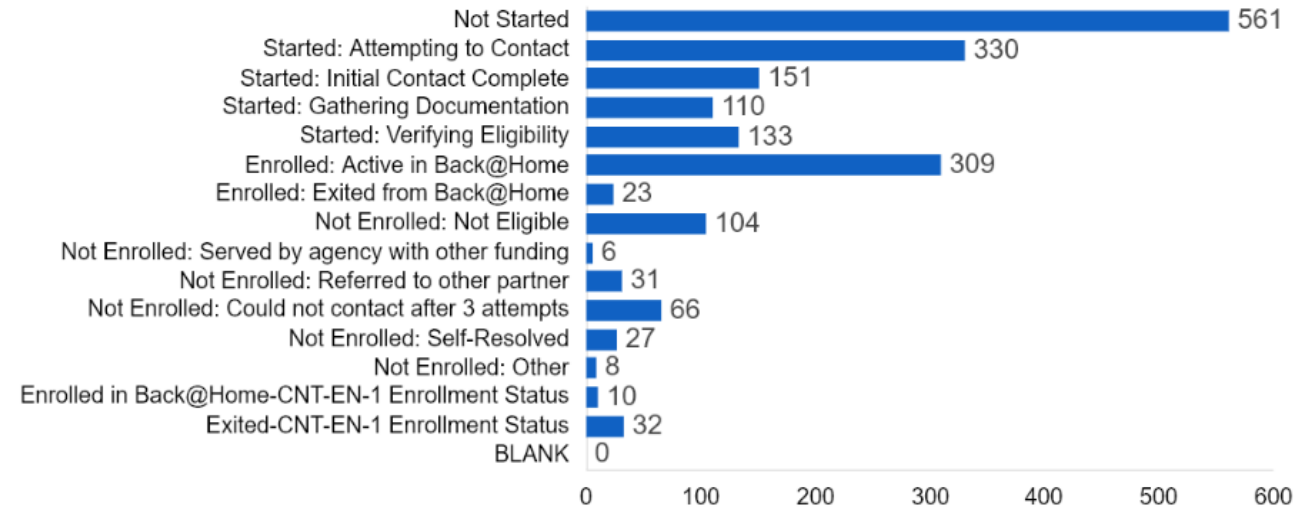

Enrollment Status Detail



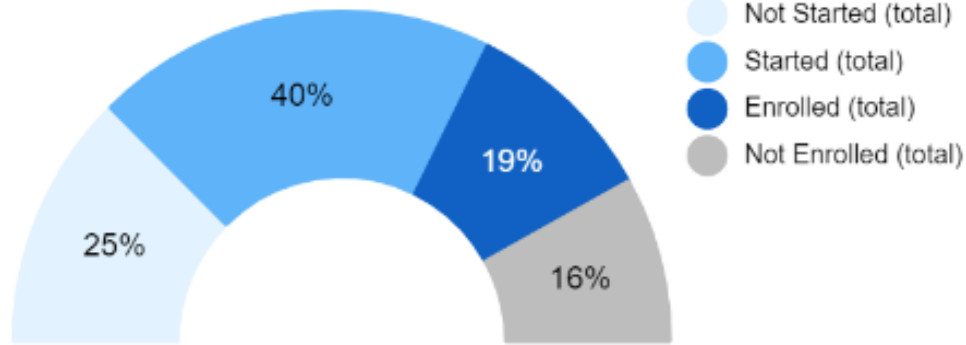

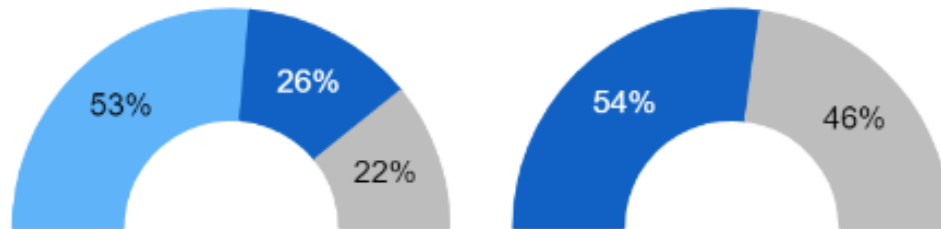

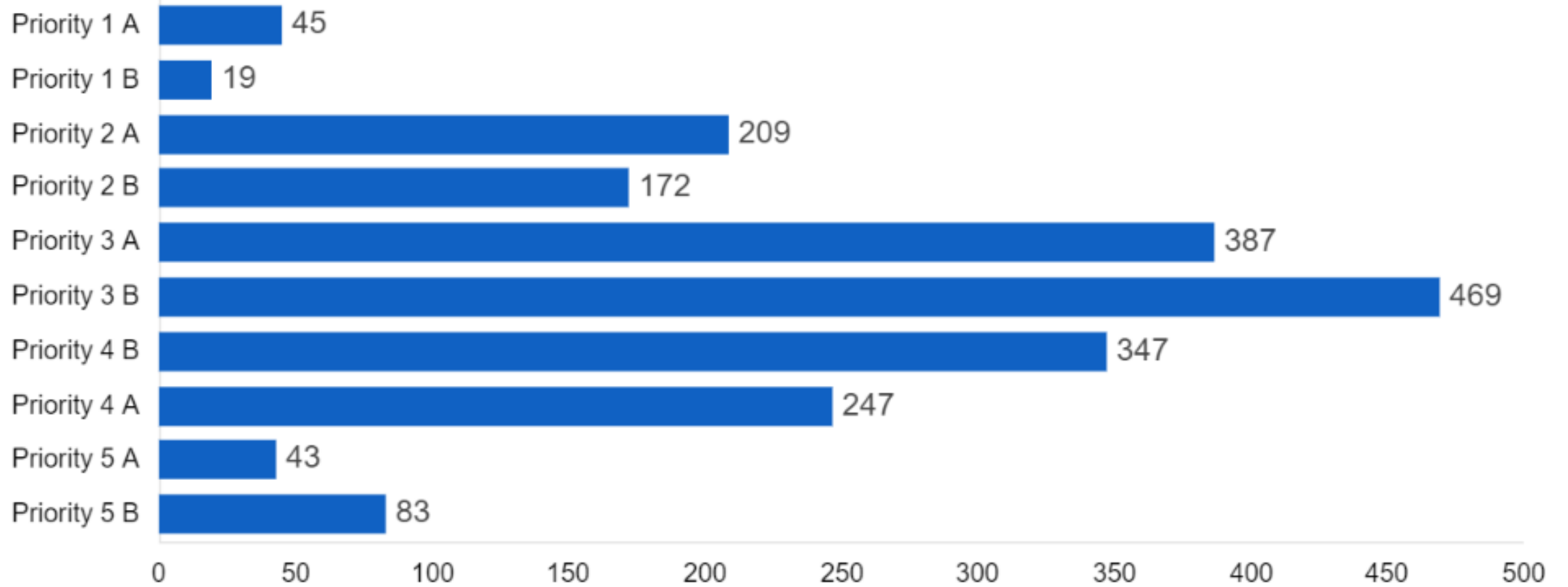


Prioritization Changed!

- New prioritization went into effect Monday 3.22.21
 - Distinction between A and B was made in smartsheet today
- New Prioritization based:
 - First on how many housing barriers the household has (Levels 1-5), then
 - Living situation (HUD literal homelessness = A, other precarious housing = B)
- Reports sorted in Priority order should auto update
- You can sort your client list by priority at any time
 - Tip: turn off filters to use sorting
