- Process- Working with Housing authorities to educate on EHV's to clarify process of referral.   - Allocation of Vouchers- Indian Affairs was rewarded 414 vouchers since they could not allocate all of these vouchers throughout the 7 counties, they agreed to take referrals from outside counties sent to the Commission of Indian Affairs.
  - Housing Authority Denials- Prior denials through the housing authority with a EHV that has been ported back to housing authority has presented issues.     - **Permanent Supportive Housing:** Orange transition has been complete, no longer taking referrals for Orange County. PSH is looking to accept some referrals from specific regions.
