TANF- Funding is available to families experiencing homelessness or facing eviction.

Housing Program Updates

Trillium Health Resources-

Community Crossroads Center- Beds are available for women and men. One hotel slot is open for families.

Greenville Housing Authority- Currently cleaning the waitlist for the HOPWA program. Permanent Supportive Housing (PSH) has availability for housing. GHA is awarded 13 Fair Share Vouchers.

Pitt County Rapid Rehousing Programs (ESG & COC)- ESG money is still available.

Center for Family Violence Prevention- Currently at capacity.
