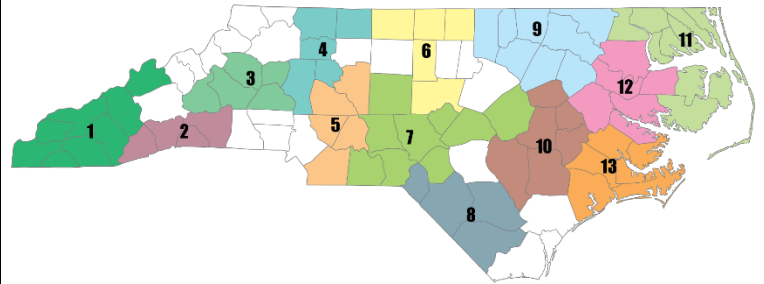

- Pamela Hinton called the meeting to order
- Minutes approved by Teena with changes to notes, Bonnie Harper seconded the minutes.
- Agency updates and Introductions:
 - Jana Elliott: The Shepherds House based in Mt. Airy and serves Stokes, Surry, Yadkin, Alleghany, and Wilkes Counties. They are a 64-bed facility hosting single women and families.
 - Alan Bagshaw: Easterseals ACTT, cover individuals that are homeless and acute mental illness with psychosis and comorbidities. Alan is hosting a “How Can I Help” series starting tonight and will be every third Tuesday of every month from 5:30 PM – 6:30 PM and will be a different topic. It will be held at the ACTT building on Lebanon Street in Mt. Airy.
 - Joey Wilson: Easterseals CST- no agency updates.
 - Teena Willis: Housing Manager at Partners.
 - Karisa McDaniel: Housing specialist for Davie and Forsyth Counties. Davie County PIT count with several partners providing resources at the Scotch Inn from 4PM to 7PM.
 - Robin Martin: Shepherds House – Case manager.

DISSY COC MEETING MINTUES

- Bonnie Harper – Manages the PSH Grant in Region 3 & 4: Burke, Catawba, Yadkin, Iredell, and Surry Counties.
- Jessica Stevens: Manager at the Shepherds House.
- Lauren Singleton: The ARK
- Troy Walkup: Shepherds House and Unsheltered Access Coordinator for Region 4.
- Mary Williams: Back at Home Rapid Rehousing Case Manager with 5th Street Ministries serving – Davie, Iredell, Surry, Stokes, and Yadkin. The program is set to end in 8 months (August), currently hiring an additional person to serve more families before the program ends.
- Debbie Owen: Case manager for the families at 5th Street Ministries, pipes burst and the family unit area are at hotels and rebuilding the whole back area and are not taking any families but have availability for singles.
- PIT Count (Troy Walkup)
 - 5th Street Ministries: Iredell County
 - Shepherds House: Stokes and Surry County
 - The ARK: Surry and Yadkin
 - Karisa McDaniel – Davie County
 - Will also enter data into HMIS.
 - From Pamela Hinton: Rob Harris- boots on ground in Iredell in Statesville 41 unsheltered people shared with Michelle at 5th Street.
 - Shepherds House having an event on the 21st on the Greenway in preparation for the PIT Count and Pamela will be dropping off care bags at the Shepherds House and The ARK on the 20th. Care Bags can only be used for Davie, Iredell, Surry, and Yadkin.
 - Troy will email out which entity will be doing the counts and entering them into HMIS.
 - Karisa has reached out to Family Promise but has not heard anything back from them.
 - The Counting Us app can be download from Google Play or Apple Store
 - There is a new form bring used for this year for non HMIS users.
