# New Privacy and Security Training

**Update:** HMIS@NCCEH Release of Information

Clients are asked to share info in two sections



# New HMIS Data Standards Taking Effect

- Updates occur every two years
- HUD's FY24 Data Standards will take place on October 1, 2023 (a Sunday)
- Key changes include:
  - More specific options for gender, race & ethnicity, exit destination
  - New collection requirements like sexual orientation for PSH, language preference
  - Updated HUD reports
- Data Center will prepare updated Paper Forms, Assessments inside HMIS, and Training
- Timeline for changes:
  - **August** for preparation and overview
  - **September** for training (alongside Annual Privacy Training)
  - **October** for full implementation





# FY2024 HMIS Data Standards

## Summary of Changes

- Standard response updates for Client prefers not to answer
- SSN only required for Last 4 Digits
- Picklist updates to Race, Ethnicity, Gender
- Picklist updates for Prior Living Situation, Current Living Situation, and Exit Destination
- New Element Translation Assistance Needed
- New PSH elements for Sexual Orientation, retiring Wellbeing
- Picklist updates for Veteran related questions, retiring Last Permanent Address
- Retiring portion of HOPWA Medical Assistance questions

If you have a report due for data in soon, submit early!

- HUD Required reports will change on or close to October 1st
- HMIS@NCCEH reports will take up to a month to re-map
- If you have any reports due in early October, we recommend submitting before Sept 30<sup>th</sup> to ensure you don't have delays.
