
## 2024 Unsheltered PIT Data

We want more counties to locate and report people experiencing unsheltered homelessness.

Last year 27 counties reported 0 unsheltered people - that's 53 counties who counted people experiencing unsheltered homelessness.

This year so far we're up to 57 counties who have an unsheltered PIT count greater than 0!



Our Data Quality reports each week look at the following issues:

- Missing Veteran Status, Gender, DOB
- Missing Relationship to Head of Household
- Missing NCCounty
- Head of Household under 16 years old / over 80 years old
- Current Living Situation date

For households with CLS "not meant for habitation" close to 1/31.

We have focused on NCCounty and the most frequent data quality issues for each region. We will be adding a flag for missing Race/Ethnicity.

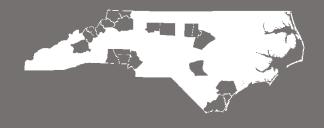

- Weather-related supplies



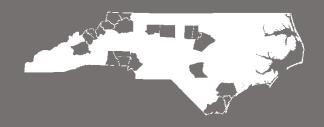
