Understanding that HUD sets a benchmark of 85% for a CoC's HMIS bed coverage


based on the Housing Inventory Count, the FPS set goals for 2024 HMIS bed coverage.

- Goal 2: The NC Balance of State CoC will increase HMIS transitional housing bed coverage to 50% by December 31, 2024.


## **System Performance Measures**

  - Definition: The length of time people stay in emergency shelter and transitional housing projects
  - Goal: Reduction in the average and median length of time persons remain homeless
  - Average Length of Time Homeless by Year:




## • Median Length of Time Homeless by Year:




• Returns to Homelessness


Percentage of Returns

- Definition: The number of persons who return to street outreach, emergency shelter, transitional housing or permanent housing projects after previously exiting to a permanent housing destination
- $\circ$  Goal: Reduction in the percent of persons who return to homelessness






- Number of Homeless Persons
  - Definition: 1). The number of sheltered and unsheltered homeless persons counted as homeless on PIT. 2). The number of sheltered homeless in HMIS in emergency shelter and transitional housing
  - $\circ$   $\;$  Goal: Reduction in the number of persons who are homeless
  - o Unduplicated Annual HMIS Count:




Total Persons in ES Total Persons in TH

# • Employment and Income Growth

- Definition: Percentage change in the number of clients with employment income, nonemployment, and total income. Divided into two groups: stayers with at least one Annual Assessment and leavers exiting during the reporting period.
  - Only for CoC Funded Projects
- Goal: Increase in the percent of adults who gain or increase employment or nonemployment cash income over time




o Increases in Employment and Income amongst Stayers:



#### • First Time Homeless


- Definition: 1). Change in the number of homeless persons in ES, and TH projects with no prior enrollments in HMIS. 2). Change in the number of persons in ES, TH, and PH projects with no prior enrollments in HMIS.
- o Goal: Reduction in the number of persons who become homeless for the first time



• Clients Served for the First Time:

#### • Permanent Housing Placement & Retention

- Definition: The number of clients enrolled in emergency shelter, transitional housing, rapid rehousing or permanent supportive housing who exit to permanent housing destination or remain in permanent housing
- Goal: Increase in percentage of people who exit to or retain permanent housing



 $\circ$   $\;$  Exits to (or Retention of) Successful Destinations:

#### • Submission to HUD

- o Data submitted by Federal Fiscal year
- o Submission is due in February(ish) each year
- o The CoC submits SPMs after Longitudinal System Analysis (usually due in Dec/Jan)
- o Data review and corrections by Agencies takes place in October and November
