- Two Housing Move-In Date Columns

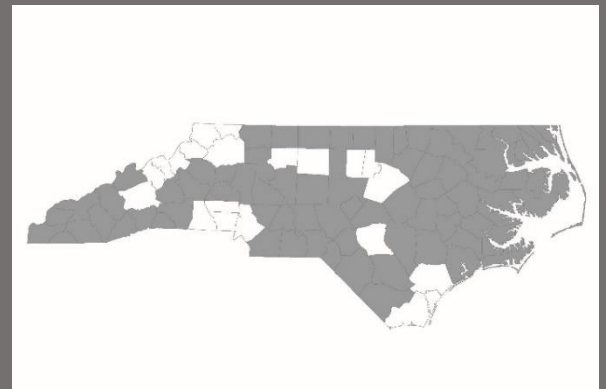


# Feedback

  - Do you want any color coding?

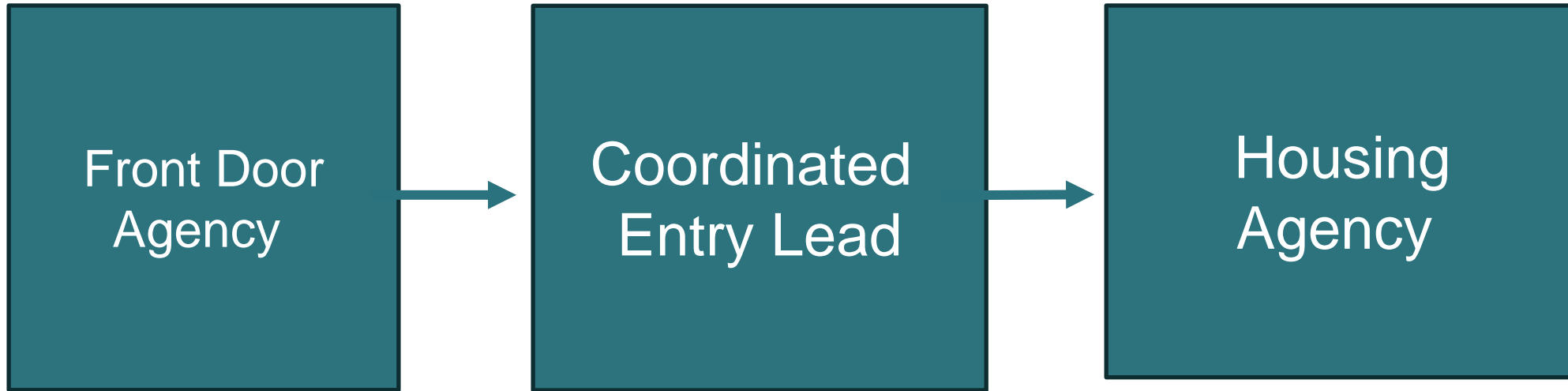

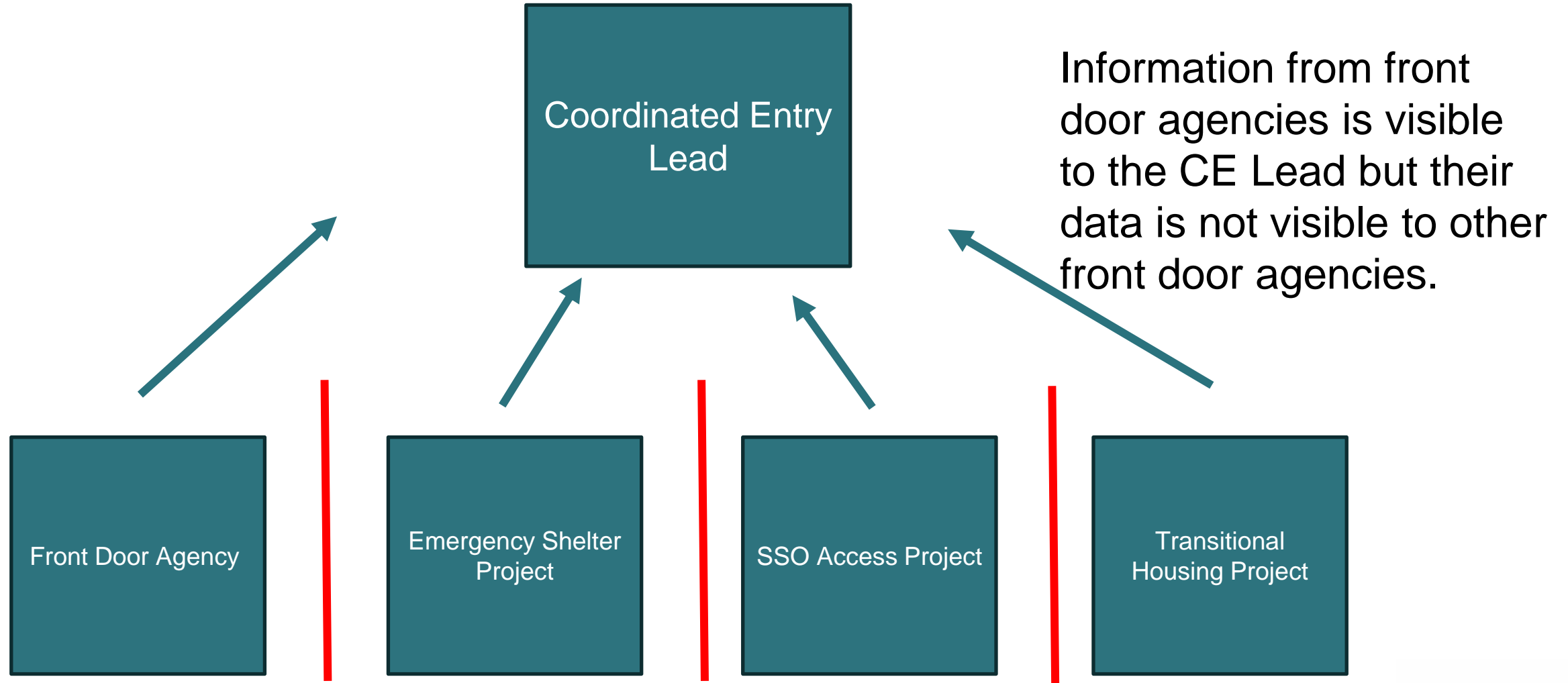
# Current Sharing Within Coordinated Entry



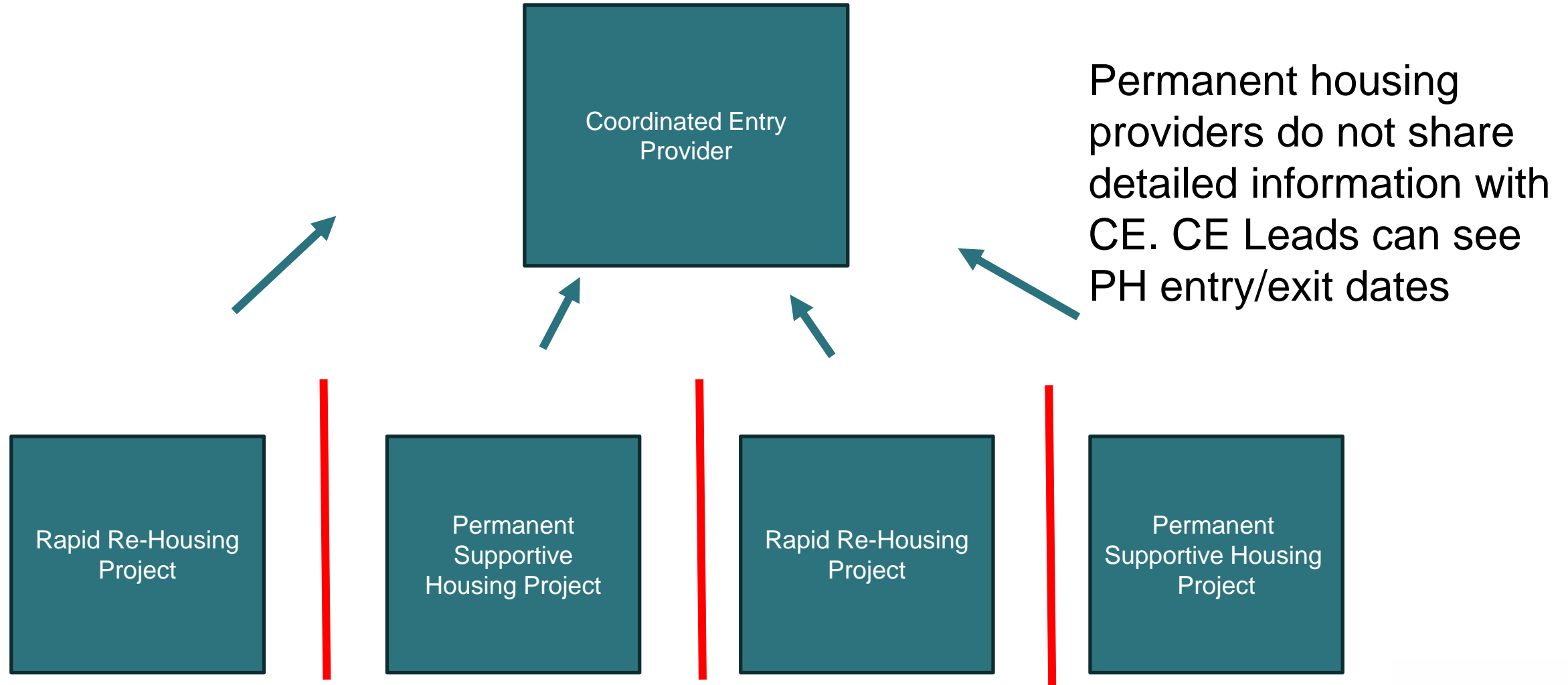

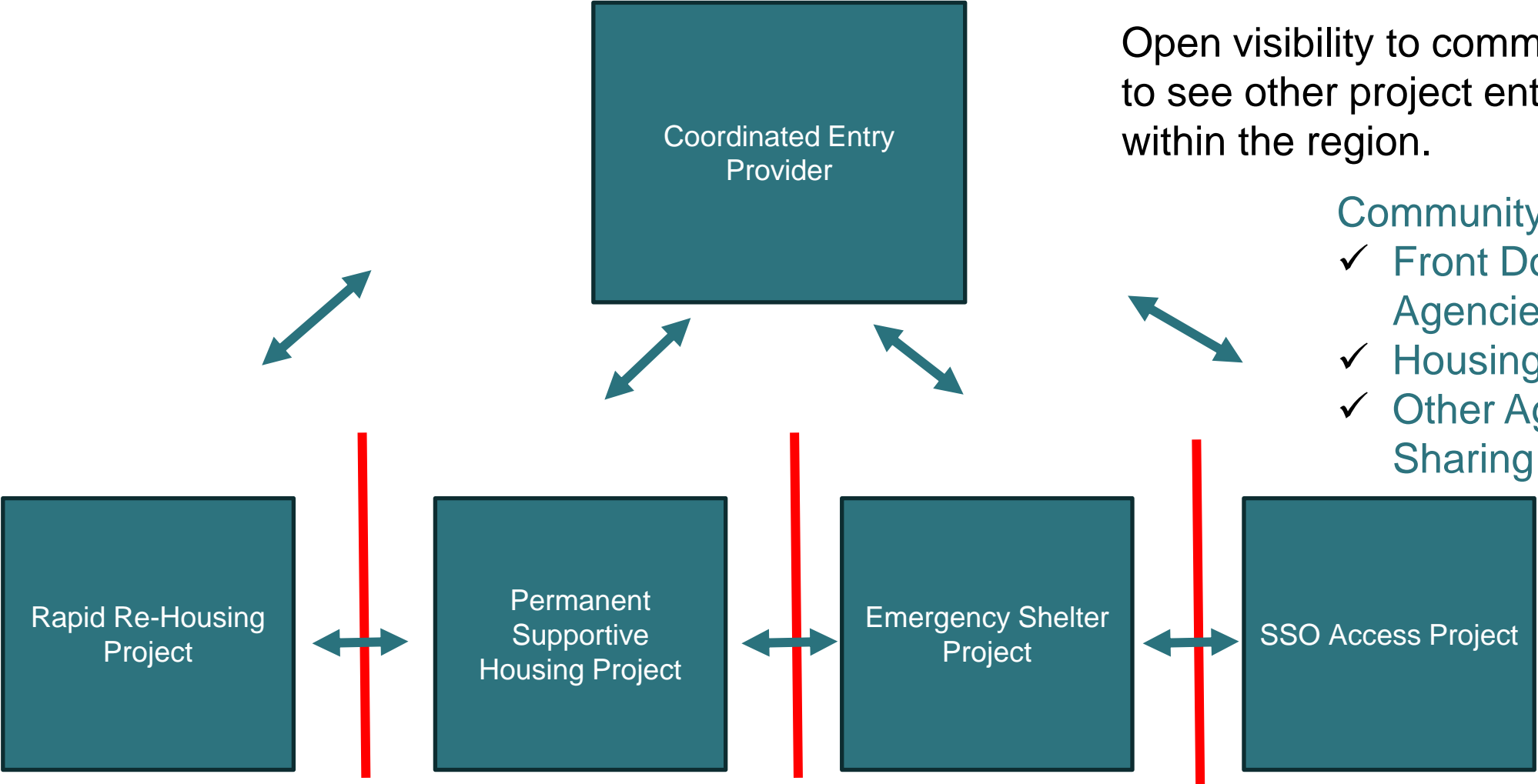

Open visibility to community projects to see other project entries and exits within the region.

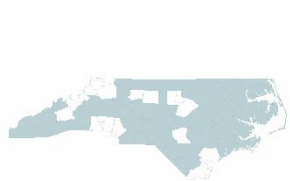

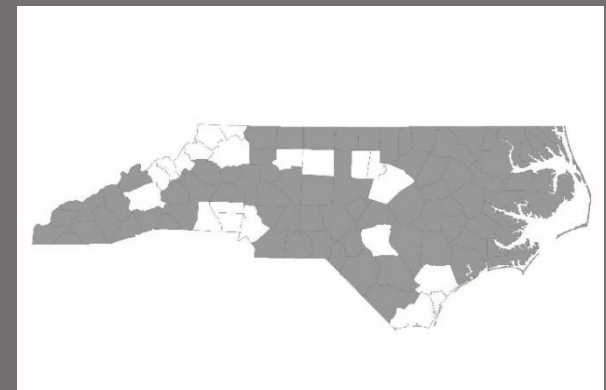

# Unsheltered PIT

- Our goal is NOT to count unsheltered households on the night of Point In Time.
- Our goal is to connected unsheltered households to coordinated entry, services, and permanent housing.
- Please ensure agencies are following up with clients living unsheltered and working to get the household assessed and connected to resources.
- Please exit households from the appropriate project if no contact can be made after 90 days.



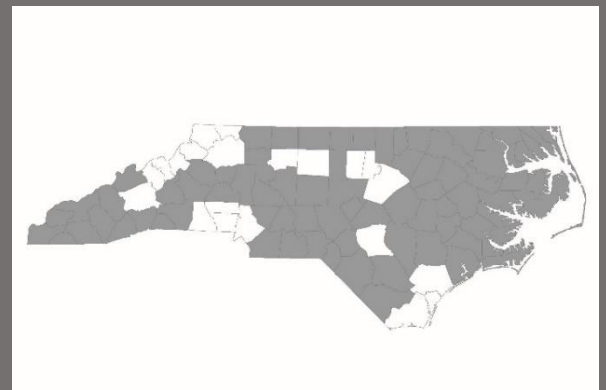


# Unsheltered PIT

- Reminder: Your goal is to ensure all people living unsheltered connect to services!
  - Build trusting relationships
  - Collect contact information for follow-up
  - Refer to emergency shelter, when possible
  - Assess and refer to coordinated entry
  - Connect to services and permanent housing

- We may be able to help!

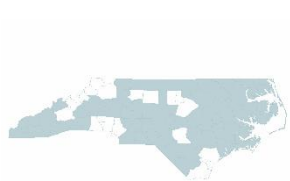
