- Teena/Partners- The housing team is working on a series of 4 trainings (landlord retention, landlord engagement, reasonable accommodations, tenancy support).
 There will be videos and live trainings in new year.
- Bonnie- She is working to get the last participant into PSH. No other updates.

- Kernersville VA- Seth didn't have any updates but reminded folks to refer and contact him for support.
- Fifth Street Ministries
 - Alexis shared that she is meeting with people on her waitlist to get them enrolled in the program.
 - o Mary shared that her caseload is full.
- Family Promise of Davie County- Their shelter/transitional housing is full, and they are accepting families onto a waitlist.
- Alan shared that he is working on clearing out a waitlist of 39 currently. They are now fully staffed and have a new housing specialist that will start face to face meetings in January. He also shared their warming station is going strong and has been open for all days below 32 degrees.
