Agency Updates:

- Mary Williams- Back at Home enrollment continues. 14 enrolled for Surry, Stokes, and Yadkin counties. 4 more needing approval at case conferencing. Davie and Iredell counties are also starting enrollment.
- Karisa- Wants to make sure that the folks identified at Davie County's PIT count get connected to services.
- Joey- No updates
- Shepherd's House- Still finalizing corrections on PIT count
- Family Promise- Transitional housing opening for a family in Davie County. Their shelter is full.
- Fifth Street- 7 new enrollments for Back at Home program in Iredell and Davie Counties.
- Brenda- PWA has no updates
- Seth- No program updates, just refer any veterans to him
- The Ark- No program updates. They are working on getting 2 single women into permanent shared housing in Yadkin County.

Point in Time Count Update:

- Unsheltered counts:
 - o Davie- 18
 - o Stokes- 1
 - Yadkin- 3
 - o Iredell- 19
 - o Surry- 60
- Shepherd's House- Street outreach event was very successful with partner agencies but didn't have a lot of unsheltered folks to show up.
- Karisa- Davie County had a great event with a variety of community partners.

Discussion:

- Outcome of survey
 - Allen was not in attendance to share outcome so this will be pushed to next month.
- Create a short summary of "Why Join DISSY"
 - Each lead was asked what they are doing to invite and retain members
 - We need to create a pitch or statement to invite individuals to join
 - Pamela- "Get what you need in one group"
 - Karisa- What is the incentive to attend meetings? Ideas on how to grow your agency, funding opportunities, collaboration opportunities, etc. "Collaboration starts at home."
 - Joey: Join the North Carolina Coalition to End Homelessness Balance of State Continuum of Care for impactful change. We're a dedicated collective committed to eradicating homelessness across the following counties: Davie, Iredell, Stokes, Surry, and Yadkin.
