- · Jana- Shepherd's House
  - Helping Hands is their partner food pantry- they are extending services to do in-depth case management with those receiving food
  - o They are hoping their men's shelter will open in the next couple months.
- Michelle- Fifth Street Ministries
  - The 4 tiny homes for Veterans are up & running! They will be for male or female Veterans.
- Karisa- Partners
  - Moving clients into housing. Used Stones Throw Ministry to furnish their housing. Got everything needed, just have to pick up the furniture since they do not deliver. Mitch Calloway- 336-366-7591
  - O Recently did a project re-entry simulation in Davie County. This went really well & was eye opening to a lot of people. Hoping to help the community understand homelessness & the need in Davie County for more housing & resources. Davie County Collaborative helped but all this together & Jerry Campbell said they will do another one next year. Tiny homes being built in Davie was brought up & we hope we can make this happen.

  - SOAR Presentation. Pamela sent out the slides.
- Laurenn- The Ark
  - Homelessness Committee in Elkin has been meeting & we are moving forward with doing Street Outreach. We are also working on connecting all the local churches to get a fund going for the unsheltered in need of a hotel.

  - Asked if The Ark had any availability. Laurenn gave her email address & asked her to reach out after the meeting.

  - Tailored Plans for Medicaid have been out for 14 days now. All is going well. Teena talked about trainings Partners has coming up in regards to

housing. Reasonable accommodation, landlord engagement, talking about Partners housing programs, and one more. Its a 4 part series.
