## Your Voice Makes a Difference

NCCEH continues to provide opportunities to convene, collaborate, and advocate to end homelessness in North Carolina.

- Advocacy during Bringing It Home got results!
- Benjiman Horton wrote an <u>op-ed</u> opposing H781 and H437 that has been printed in several NC newspapers.

Angela Harper King expressed her appreciation for the agency and specifically acknowledged Debra's contributions.

## **RUSH 2 Funding – Letters of Support**

Funded by the US Department of Housing & Urban Development, a second special allocation of "Rapid Unsheltered Survivor Housing" (RUSH) has been issued to address the impacts of Hurricane Helene on Federal disaster-declared areas.

These special RUSH 2 funds are to be used to address the needs of homeless individuals and families at risk of homelessness in areas affected by a major disaster, whose needs are not otherwise served or fully met by existing Federal disaster relief programs, including the Transitional Sheltering Assistance (TSA) program.

The North Carolina Department of Health and Human Services (DHHS) will administer North Carolina's RUSH 2 funds totaling \$1,910,417.

- Each applicant within the NC BoS CoC must obtain a letter of support for their application.
- 5 agencies submitted requests for Letters of Support for their applications for RUSH 2 funds.

## **Pisgah Legal Services**

Letter of Support request to provide *legal services* through a *Homelessness Prevention* program:

- Service area:

  - Homelessness Prevention: \$69,200 (\$20,800 for services; \$48,400 for financial assistance)

## CY2026 Total Amount Available for NC BoS CoC?

The NC ESG Office sets a total amount that each of the NC BoS CoC's 13 Regions can apply for, the Fair Share.

- This helps make sure that funds do not get concentrated in one part of the state.
- Important for each region to work with providers to submit quality applications for ESG Program eligible activities that meet the needs of the Region and utilize the region's entire Fair Share!

While the overall ESG award to the entire state will be \$5,169,928, which is a \$9,802 increase over last year, the NC ESG Office has not yet released each region's fair share.

Lisa Worth from the NC ESG Office noted in the chat that fair share information should be published tomorrow, June 4.

## **ESG: Emergency Solutions Grant Program**

From the ESG Policy and Procedure Desk Guide


*Purpose:* NC ESG Program funds are intended to be used as part of a crisis response system using a low barrier, housing-focused approach to ensure that homelessness is rare, brief, and one time.

HUD's Priorities for ESG:

- Broaden existing emergency shelter & homelessness prevention activities
- Emphasize rapid rehousing
- Help people quickly regain stability in permanent housing after experiencing a housing crisis &/or homelessness

For every activity type, ESG Program funding should assist people in accessing & maintaining permanent housing!

#### **Conflict-of-Interest Policy**

Persons attending Steering Committee or Regional Committee meetings representing an agency applying for CY2026 ESG Program Funding may **not**:

- Participate in conversations about applicants
- Facilitate Regional Committee meetings to recommend agencies for funding
- Ask questions about the funding proposal for your agency
- Make a motion related to approving or recommending an agency for funding.
- Represent the region on the Project Review Committee
- Vote on the Regional Review Form (at the Regional level) or proposed slate of applicants (at the Steering Committee level)

#### Avoiding a Conflict of Interest

- Make a plan *now!*

#### Why Data Matters


Data Quality matters because it tells the story of the clients homeless situation.





# **Opening Sharing and Visibility in BoS**




# **Current Sharing Within Coordinated Entry**

Please Complete Our Survey Here: <u>https://forms.gle/UPGbeRLm85RdQF2C9</u> Catonnia Pitt inquired about the data-sharing process for domestic violence (DV) shelters. Teresa Robinson clarified that the process remains unchanged, as all information is treated as confidential.

 Andrea Carey added:"Thanks for the great question. Victim Service Providers are not allowed to enter data into HMIS, so this won't impact them. However, Coordinated Entry (CE) and other projects may serve individuals fleeing domestic violence within HMIS. These clients retain the right to restrict access to their profiles. Clients or agencies can notify the Data Center if someone wishes to limit data sharing—either now or in the future."

Lynne James asked how the changes might impact HMIS Release of Information (ROI) forms.

 Andrea responded: "Good question! It doesn't impact the ROIs because our Privacy Notice already includes a provision that data sharing is subject to change. However, we will need to discuss how to procedurally inform clients. Additionally, we would need to re-sign the sharing agreements."

Lori Watts raised a concern about Managed Care Organizations (MCOs) that have restrictions around sharing mental health (MH) and substance use (SU) data.

- Teresa replied: "We can certainly follow up one-on-one to address your specific concerns. The survey outlines different sharing options where you can choose what data to share. MCOs would need to establish new sharing agreements as well."
- Lori noted: "It took us an extra year to get the current agreements signed, as they had to go through legal review. I'm not sure our legal team will support expanding data sharing for our members."
  - Andrea responded: "Copy that, and it's a good reminder! MH and SU data are currently held in the 'Dynamic Entry/Exit' fields. Perhaps sharing only static entry and exit dates could still be feasible. We've created a visualization of the different sharing options here: <u>Sharing Options Form</u>."

Teena Willis added: "I agree with Lori—we need to consider the impact of HIPAA requirements for LME/MCOs."

## CoC Program Competition Updates

## HUD Re-released a special CoC Builds NOFO on Friday, May 16<sup>th</sup>.

HUD re-released a new funding opportunity for construction, acquisition, or rehabilitation in a Notice of Funding Opportunity (NOFO) called CoC Builds on May 16th.

This NOFO supersedes the CoC Builds NOFO released last July 19th. Any applications submitted need to be reconsidered and submitted under the current NOFO.

HUD will select project applications to fund:

- New PSH specifically for people experiencing homelessness which must include capital costs budgeted for new construction, acquisition, or rehabilitation; &
- Up to 20% of an award for CoC Program eligible activities & costs associated with such new PSH project & no more than 10% for admin costs

Under the NOFO, several entities are eligible to apply:

- State, county, municipal, or special district governments
- Federally recognized Native American tribal governments
- Public housing authorities/Indian housing authorities
- Native American tribal organizations (other than Federally recognized tribal governments)
- 501(3) nonprofit organizations

Faith-based organizations may apply on the same basis as any other organization.

The NC Balance of State CoC may apply for (1) project up to \$9 million (a second project specifically by Tribal Reservations or Trust Lands could be applied for).
