ESG Program Overview

ESG: Emergency Solutions Grants

From the ESG Policy and Procedure Desk Guide

Purpose: NC ESG Program funds are intended to be used as part of a crisis response system using a low-barrier, housing-focused approach to ensure that homelessness is rare, brief, and one time.

Activities can include:

- Engaging people living unsheltered.
- Improving the number and quality of emergency shelters, Assist in meeting the costs of operating emergency shelters, Provide essential services to emergency shelter residents
- Rapidly rehouse persons who are currently experiencing homelessness
- Prevent people from becoming homeless.




HUD's priorities for the ESG Program.


- Broaden existing emergency shelter and homelessness prevention activities
- Emphasize rapid rehousing
- Help people quickly regain stability in permanent housing after experiencing a housing crisis and/or homelessness

For every activity type, ESG funding should be assisting people to access or maintain permanent housing!




ESG Program: 5 Eligible Activities

Regional Fair Share

- The NC ESG Office sets a total amount that each of the NC BoS CoC's 13 Regions can apply for, the Fair Share.
 - This helps make sure that funds do not get concentrated in one part of the state.
 - Important for each region to work with providers to submit quality applications for ESG Program eligible activities that meet the needs of the Region that utilize the entire Fair Share!




The 60/40 split in a Region's Fair Share

The mandated distribution of funds between Emergency Response
 & Housing Stabilization projects.
 Minium of 40% of Regional

Emergency Response: A MAXIMUM of 60% of the Regional Fair Share MAY be allocated to Street Outreach &/or Emergency Shelter.

Housing Stabilization:

A MINIMUM of 40% of the Regional Fair Share MUST be allocated to Rapid Rehousing &/or Homelessness Prevention.

HMIS (Comparable Database) Funding

- The "HMIS" activity type can be utilized for HMIS & Comparable Database required of Victim Service Providers.
- Having dedicated HMIS (or comparable database) funding can help address the staff capacity needed to enter quality & timely data!
- HMIS funding is not included in the 60/40 split. It is a part of the Regional Fair Share but is taken "off the top".

Role of Regional Committees

Spread the word and start now!!!

- Providers in your regions may not hear critical information about application deadlines & materials if it does not come from you.
- Encourage any interested providers to email <u>bos@ncceh.org</u> & request to be added to our general email list.
- Forward all ESG Program competition information to your networks, especially the CoC's application instructions! All instructions will be posted at: <u>https://www.ncceh.org/bos/esg/</u>
- Review ESG Program Competition information in your regional meetings.

• Be prepared to get the correct answers to questions!

- Applicants may come to you before asking NCCEH staff.
- Very important that you have the correct information.
- If you don't know, don't guess! Direct people to email <u>bos@ncceh.org</u>.



Supporting your Regional providers in submitting quality applications

- As you talk with agencies in your region, or as you prepare your own applications, *remember:*
 - It's very important to read the Project Application Instructions thoroughly!
 - Plan to attend the webinar on June 18 from 1 PM 2 PM
 - Now is a good time to reference the NC BoS CoC Written Standards for the project type for which you are applying. A review of all applicants' policies & procedures will be done as part of the application process to assess adherence to the Written Standards.
 - *Now* is a good time to get your HMIS/comparable database data cleaned & upto-date. Project performance will be scored using the Annual Performance Report (APR).
 - We're using the APR rather than the CAPER because it has more comprehensive data.
 - VSPs will be expected to produce the APR from their comparable database.



Updates to ESG in the NC BoS CoC

CY2026 ESG Program Funding Priorities

- The ESG Program Funding Priorities document has been updated for CY2026 & was approved by the Steering Committee.
- It is available on the NCCEH website: <u>CY2026 ESG Program Funding</u>
 <u>Priorities</u>
- Minor updates from the CY2025 version for clarity, with 2 key changes:
 - Key change:
 - Applicant agencies must attend 75% of regional committee meetings.
 - Applicant agencies must attend 85% of Coordinated Entry case conferencing, as applicable.



Updates to ESG Scorecard

- Key updates from the Funding Priorities have been added to the scorecard.

Regional Review Form

What is the Regional Review Form?

The Regional Review Form IS:

- An opportunity for Regional Committees to provide input on the applicants in their region applying for ESG Program funding.
- An opportunity to notify NCCEH staff & the Project Review Committee if an agency applied for ESG Program funds that does not participate in Regional Committee in at least 75% of the region's meetings between June 1, 2024 and May 31, 2025 & 85% of Case Conferencing meetings during the same timeframe.

The Regional Review Form IS NOT:

- A final decision on which projects are funded.
- A decision regarding the funding amount awarded to any project applicant.



When is the Regional Review Form completed?



Regional Review Form will be sent to Regional Leads & Alternates as early as we can on the afternoon of Tuesday, July 15, 2025.



The Regional Review Form needs to be completed and returned by the deadline of 12 PM (Noon) on Friday, July 25th to be considered by the Project Review Committee to create the proposed slate of applications & for NCCEH staff to complete the Regional Application.

Hold a Regional Committee meeting between July 16th and July 24th.

 The meeting or the portion of the meeting addressing this form must be facilitated by a leader <u>who does not have</u> <u>a conflict of interest</u>.

Areas in yellow need to be completed:

- Regional Webmasters and CE Leads need to find this data ahead of the Regional Committee meeting.
- Agencies new to ESG Program funding in this year's competition who aren't attending CE, should be explaining how they will be attending case conferencing meetings once awarded ESG Program funds.

Hold July Regional Meetings between 7/16 & 7/24

- Conduct regional meetings for July between July 16th and July 24th to conduct regular business AND complete the Regional Review Form
- Regional Review Forms are due to NCCEH by 12 PM (Noon) on July 25th.



Conflict of Interest

Conflict-of-Interest Policy

- Persons attending Steering Committee or Regional Committee meetings representing an agency applying for CY2026 ESG Program Funding may
 - <u>Attend the meeting for the Regional Review Form.</u>
- <u>They may not</u>:
 - Participate in conversations about applicants
 - Facilitate Regional Committee meetings to recommend agencies for funding
 - Ask questions about the funding proposal for your agency
 - Make a motion related to approving or recommending an agency for funding.
 - Represent the region on the Project Review Committee
 - Vote on the Regional Review Form or proposed slate of applicants (Steering Committee meeting only)



Avoiding a Conflict of Interest

- Make a plan now!
- Who will facilitate the Regional Committee meeting to complete the Regional Review Form? Plan on scheduling this meeting between July 17 and July 24th.
- Who will complete & return the Regional Review Form by 12 PM (Noon) on Friday, July 25th?

*Note: The CE Leads & Webmasters do not need to abstain from providing attendance info for Case Conferencing & Regional Committee meetings for applicants.
