

# STEP 1 UNDERSTAND THE NOFO GUIDELINES

**Read the NOFO Carefully** - When the NOFO is released, focus on its specific language and narrative, including topics identified as priorities, such as: treatment and recovery,







### Weekly Update - Recent Events

- In 2024, HUD released its first-ever **2-year Notice of Funding Opportunity (NOFO)** for the Continuum of Care (CoC) Program.
- The FY 2024 CoC Competition followed protocols and processes familiar to communities nationwide. The upcoming FY 2025 CoC Competition would have represented the second phase of this 2-year NOFO cycle.
- On July 3, 2025, HUD emailed updated guidance to CoCs that reflects new federal administration priorities.
- A corresponding Congressional funding bill was passed on **July 4, 2025**, formally solidifying HUD's new strategic direction into law.
- Congress is in recess until Sept. 2, 2025.
- The Grant Inventory Worksheet Change Form was submitted to the HUD SNAPS office on time. As of Aug. 28, 2025, we are still waiting for a response from the HUD team.





#### **Find Common Ground**

- Lead with curiosity. Start by listening to what motivates your local faith communities.
- In outreach conversations, make an explicit connection to shared values and missions (i.e. housing for all, service, justice, or care).
- Remember that partnership is formed through consistent and authentic engagement.

#### **Build Relationships**

- Ask leaders about their congregation's priorities.
- Explore alignment with priorities as it relates to your program's focus.
- Invite groups into CoC membership and collaboration.
- Strengthen the partnership by assigning a clear point of contact for new agencies; ensure a continuous feedback loop.







### **Leverage Mutual Strengths**

- Utilize mutual, flexible, resources such as volunteers or in-kind donations.
- Explore the use of meeting spaces or properties for events, housing, or services (i.e. community meals).
- Attend events at faith-based and public organizations to discuss existing CoC resources and how to connect.

#### **Create Opportunities**

- Create tiered opportunities for engagement so folks can start where they're comfortable (i.e., anywhere from "one off" events to long-term collaboration).
- Identify what are agencies' essential needs are for support, and what is flexible.
- Explore non-traditional approaches for service. Faith-based agencies may have creative or relational service models that may be more comfortable for some individuals experiencing homelessness and housing insecurity.





#### **Build the Network**

- Cross-train volunteers from public faith based organizations.
- Onboard new partners to housing program activities and opportunities for engagement.
- Share program performance outcomes with public and faith-based organizations.

- Work with NCCEH to help elevate your concerns and advocate with you.
- We invite renewal programs to please read through your application and potentially be prepared to reframe how you describe your program. Don't stop or interrupt day-to-day activities.
- An administration EO intends to require approval for financial draw downs. This may mean there will be different time frames on drawing down money (i.e., months in advance).
- Be ready for unexpected changes at any time, this year's process may or may not look like what was expected.
