CY2026 ESG Program Competition Update on Appeals

Appeals submitted by August 8th deadline of 12 Noon.

- NCCEH received 2 appeals by the August 8th deadline of 12 Noon.
- All documentation received for each appeal was sent via email through Smartsheet to Project Review Committee members for their review.
- On Monday, August 11th at their 2 PM meeting, the PRC determined that neither appeal submitted met the criteria as an eligible appeal.
- NCCEH will send emails to those agencies this afternoon indicating their submissions were ineligible.
- Based on our Appeals Policy, since the submissions were found ineligible and decisions from last week are not being recommended to change, there is nothing for the Steering Committee to review.

For next year's competition, Karen Carroll suggested hosting a voluntary Zoom meeting where participants could ask questions and receive feedback on what they've submitted. She also

recommended that staff set an application deadline early enough to allow time to review all materials and follow up with organizations that did not submit all required documents.

CY2026 ESG Program Competition Review of Region 9

Region 9: Oversight of Project Application Submitted

- Greene Lamp submitted an application for RRH and HP in Region 9 before the extension deadline of July 21st at 12 Noon, but it was not included in the pool of applications assigned for review.
- After the Steering Committee review and approval of the PRC recommendation last Tuesday, Greene Lamp staff reached out to inquire if NCCEH had received their Region 9 application.
- Their email was found, titled "Region 9 ESG Application Submission. The body of the email indicated the application was for services in Beaufort, Martin, and Washington counties, which are in Region 12. The application materials attached were, however, for RRH and HP in Nash and Edgecombe in Region 9.
- When this oversight was brought to our attention, it was assigned to a staff person for review.
- The Regional Review Form was revised and reissued to Regional Leadership in Region 9 for input, feedback, and return to NCCEH.
