





### 1. Policy Updates

### **HUD FY25 NOFO Update**

- HUD has rescinded the FY25 Notice of Funding Opportunity (NOFO).
- As a result, the FY25 CoC Competition is currently paused because there is no active NOFO or available funding at this time.
- The Balance of State is advising applicants to continue working on their applications in ZoomGrants, although there is currently no deadline.

### 2. Client Bill of Rights Review

#### **Purpose of Revisions**

- The Client Bill of Rights is a required policy document for applicants seeking federal funding.
- Due to the current federal administration, certain language in the existing version could be flagged and potentially jeopardize funding.
- To preserve the Client Bill of Rights as a requirement, staff proposed edits to remove language that could raise concern while maintaining the spirit and intent of the document.

#### **Key Sections Reviewed**

The Council reviewed and discussed the following sections:

- Equity Statement: Access and Outcomes
- Principle of Housing First and Reducing Barriers
- Services Free of Discrimination
- Self-Determination
- Transparency in Agency Policies

#### 3. Voting Options and Next Steps

Members present agreed with the document as written. The present LEAC members wanted to give the absent members a chance to review the changes and content of the meeting before we send the revised Client Bill of Rights to the Steering Committee for approval.
